NARFE CHAPTER 1192 EXECUTIVE BOARD MEETING MINUTES December 30, 2015

President Lorie Bennett called the meeting to order at 12:05 p.m., Tri-City Country Club, Kennewick. Members present: Lorie; Mary Binder; Liz Bowers; Nancy Crosby; Bill Darke; Pat Turner; Larry Williams. Absent: Johanna Caylor; Pam Griffin; Steve Howes.

President/Service Officer/Special Programs: Lorie Bennett.

- NARFE Strategic Plan, December 2015 The board discussed the report. Members were interested
 in/concerned about the path forward. As this will remain a top NARFE priority, including an agenda
 item at the WSFC May convention and NARFE's national convention, the board concurred that the
 plan needs to continue to be an agenda item at our chapter meetings. Members will continue to be
 encouraged to read the report. Mary included some report highlights in the current chapter newsletter.
- 34th NARFE National Convention, August 28 to September 1, Grand Sierra Resort and Casino, Reno NARFE distributed to NARFE leaders an advanced copy of the committee assignment request form and information about the committees, duties and time commitments. The form and other convention information are scheduled to be on the NARFE website in January. Requests to serve on a committee must go through an approval process chapter president to federation president to regional vice president before going to NARFE for consideration. Board members were encouraged to consider serving on a committee. Board members currently planning to attend the convention are: Lorie (and Leon) Bennett; Mary Binder; Nancy Crosby; Larry Williams.
- Board Action Items Mary proposed establishing a "board action items" list after each board meeting
 to help members remember what they are tasked to do and to track actions. Mary would send out the
 list as part of her secretarial duties. The board concurred with trying this initiative.
- Turning off/silencing mobile devices Lorie proposed adding a reminder at the beginning of meetings about this issue, including if members need to take a call that they leave the meeting room. The board concurred. Mary will add the reminder to the agenda.
- Meeting email blasts to members the board discussed sending a meeting reminder blast to
 members whose addresses we have as another tool to get members to attend meetings. Nancy said
 she could modify the newsletter email list so it includes only local members. Lorie and Nancy are
 working this initiative and targeting sending a blast for the February meeting.
- Annual chapter food drive Mary said that for the past few years the chapter's food drive has been at
 the January meeting. The board agreed to have the drive in March. It'll be announced at the February
 chapter meeting, the callers will remind members when they contact them for the March meeting, and
 Mary will include a reminder in the March/April chapter newsletter.
- Nancy will install Directors-at-Large Liz Bowers and Steve Howes at the January chapter meeting.
 [Due to an oversight, they were not installed in December.] Nancy said she has new NARFE badges for Pat and Liz.
- Hospitality all is OK.
- Service Office:
 - No report from Johanna regarding the potentially missing member renewal check that was slid under the SO door last fall. Per discussion at the November board meeting, Johanna said she would check with the member to see if the check has been cashed.
 - Mary said the SO time listed on the NARFE website is not correct. Lorie will work with NARFE to get this corrected.
 - Service Officer of the Year Award Mary will be preparing the nomination package. It will need to go from the chapter to the federation. Per award guidance, a federation president selects one nomination to forward to the NARFE regional VP who can then select one nomination from their federations for the region and forward to NARFE. Deadline for nominations to be received at NARFE is January 30.
 - Dorothy Smith has retired as a SO volunteer. Nancy has received a picture of her. The board discussed recognition options.

1st Vice President: Pat Turner. No report.

2nd Vice President/Webmaster: Larry Williams.

- Larry reported on a recent issue with the chapter's website it was "hijacked" by a "phisher." He highlighted what happened, what was involved and the steps taken to resolve the issue. Those with names/contact information on the site also were involved, e.g., Nancy Crosby and Johanna Caylor. All is now resolved.
- Larry said he has spent time learning about the new NARFE Electronic System (NES). While there are
 many new/improved features from the previous system [GEMS], there are some challenges. Larry said
 he will continue to work with the system.
- In reviewing the website's statistics recently, Larry said the activity was normal, e.g., the number of "hits," when they occur. etc.

Secretary/Sunshine/Newsletter/Public Relations: Mary Binder.

- January/February newsletter finalized, printed/distributed, emailed. [Due date for March/April newsletter articles is Friday, February 5.]
- Chapter Officer/Chairman Roster Johanna previously suggested adding the "callers" names/phone numbers to the roster. The board discussed this and concurred with the recommendation. Mary will work with Pam to get current contact information, update the roster and distribute it.
- Table Top Displays no progress.
- 2016 Outreach Action Plan Mary provided the board the 2016 draft plan. Other than minor tweaking for cost changes, it is the same as for 2015. A motion was made and seconded to approve the plan. The board approved the plan. Mary will send it to Sam Cagle, WSFC PR chairman, for approval with a copy to WSFC President Rich Wilson.
- 2016 NARFE Photo Contest deadline for submissions is March 15. This year's theme is "Made in America." Responding to a question, Mary gave some examples of what this means. She said examples are also in the current *WSFC Federation Reporter*.
- Sunshine Johanna has not been feeling well. Former member Norm Moorer passed away recently.
