NARFE CHAPTER 1192 EXECUTIVE BOARD MEETING MINUTES June 23, 2015

President Lorie Bennett called the meeting to order at 12:35 p.m., Tri-City Country Club, Kennewick. Besides Lorie, Board members present: Mary Binder; Nancy Crosby; Bill Darke; Pat Turner; Larry Williams. Absent: Johanna Caylor; Pam Griffin; Steve Howes.

President/Service Officer/Special Programs: Lorie Bennett.

- Chapter structure and bylaws President Lorie and the board discussed the current board structure, e.g., having 2 vice presidents; should the chapter have social/associate members. For now the board opted to keep the structure as it is, check NARFE's bylaws regarding social and associate members, and check with the Spokane chapter to see if the chapter now has this membership category. Larry Williams will remain as 2nd vice president; the 1st vice president position is vacant.
- WSFC vacancies the vice president, legislative chairman, membership chairman/co-chairmen and NARFE-PAC chairman positions are still vacant. WSFC President Rich Wilson is also pursuing a treasurer as current treasurer, Arlene Patton, stated she wants to step down by June 30.
- FON/Strategic Planning the NARFE Strategic Planning Committee met again electronically yesterday, June 22. Meeting summary will be posted on the NARFE website under the "Strategic Planning" banner on the member homepage. Previous meeting information is at that site.
- Hospitality the board reviewed and discussed the chapter's meeting location, menu changes made for 2015 and lunch costs. The board consensus was to stay with the Red Lion, that the menu changes have been positively received, and if possible, keep the lunch costs the same. Nancy Crosby volunteered to serve as the point of contact with the Red Lion catering manager.
- Chapter officer elections per the chapter bylaws, the president needs to appoint a nominating
 committee by not later than the September chapter meeting. Nominations are at the October meeting;
 elections at the November meeting; installation of officers at the December meeting. Director-at-Large
 Pat Turner volunteered to chair the nomination committee. The board discussed possible committee
 members. Pat will pursue.
- NARFE forms/publications orders to NARFE will go through President Lorie for review and coordination. The board discussed having a supply of the NARFE F-100s, Be Prepared for Life's Events, What Your Survivors Should Know, at chapter meetings. There is a supply of these in the service office.
- Service Office the information on the NARFE website for our chapter's service office needs
 updating; Lorie will work this issue. The office will remain open Tuesdays during the summer. For now
 having a service office open house/anniversary celebration is on hold. Also, Mary said she has still
 not heard anything regarding being able to submit the service office vs. the service officer for
 NARFE's annual award. Nancy announced that the Walla Walla chapter's service officer, Phyllis
 Garvas, is NARFE's service officer of the year.
- Dust Devils game, June 24 Lorie said the chapter has 13 people signed up to attend and that seats in 2 rows are reserved.
- Other chapter group activities none right now, but a reminder about the Tall Ships will be in the Tri-Cities, July 31 to August 10.

1st Vice President: Vacant.

2nd Vice President/Webmaster: Larry Williams.

- Larry said he has gotten on the NARFE website and reviewed the new NARFE Electronic System (NES), but hasn't yet done much with it. It does have more capabilities than the old system, including the capability for mass mailings to members at the national and chapter levels. Larry will check on who can set up/change the listings.
- Larry reported that he'd completed updates to the chapter's website, including removing Don's name. He also shared an "anomaly" he discovered in reviewing the April stats, why that may have happened and a path forward, e.g., deleting the "guest book" option as it takes up "bandwidth."

Secretary/Sunshine/Newsletter/Public Relations: Mary Binder.

- July/August newsletter Mary said she is still working on the newsletter, but behind schedule.
- 2015 Senior Life Show, June 18, recap the chapter did have a table, and it was staffed by several chapter volunteers. A number of people stopped by; some completed the prospect card. Nancy has the cards/copies. The 2016 Senior Life Show date is June 9.
