- Sunshine – Member Sue Avery passed away; Mary will send a card.

### **Treasurer:** *Nancy Crosby*

- Name badges – Nancy had prepared name badges for members to wear at meetings and return after each meeting. Nancy will maintain the badges and bring them to each Chapter meeting. Board members spent time after the meeting assembling the badges.
- 2014 Chapter budget – Board reviewed/discussed draft Nancy presented with a focus on maintaining treasury funds wherever possible. As it has been several years since the Chapter hosted a convention and/or had other “fundraisers,” the Chapter’s treasury has continued to decline. Nancy will update the draft and resend to the Board for review prior to the November chapter meeting.

- 2016 WSFC Convention – Nancy, and Don and Mary Binder, met with Tri-Cities Visitor & Convention Bureau representative to review hotel proposals. They are scheduled to do site visits Monday, November 25.

## **COMMITTEES**

### **Caller Coordinator:** *Pam Griffin*

- At the October Chapter meeting, Debbie Lopez and Ruby Ulseth volunteered to be callers. Mable Rutt has resigned as a caller.

### **Legislative:** *Don Binder, Mary Binder*

- Chained CPI – Don said NARFE is continuing to monitor this; joint House/Senate budget committee meetings are ongoing
- COLA for 2014 – just released today; 1.5 percent.

### **Membership:** *Johanna Caylor/Sig Preston*

- October Health Fairs – with the government shutdown, there was confusion as to whether there would be health fairs. Fairs at TSA and Social Security had no chapter representatives; but, Johanna and Sig attended the fairs at the Federal Building and Stevens Center in Richland. Four employees completed membership applications; a number of others completed M-2 cards. Their names will be included in a drawing for one of three free one-year NARFE memberships the Chapter is providing. Johanna said she’d like to return to using “packets” at the fairs vs. just the membership applications, *narfe* magazine and M-2 cards as several employees asked about the packets.

- NARFE M-114 report – Johanna is reviewing the latest report and working to correct a number of discrepancies, e.g., AFEs who have retired. She said she was excited that 85 chapter members now use dues withholding. Further the chapter has about 35 AFE members and more than 25 in the “Distinguished Member” category.
- Membership applications and M-2 cards – Don has ordered a supply of both.
- Nancy said she has been sending membership renewal reminder postcards.

**NARFE-PAC:** *Frank Griffin* (Don provided an update in his role as the WSFC PAC coordinator.)

- PAC contributions – to date for the 2013/2014 cycle, NARFE has given Washington Rep. Denny Heck \$3K and \$2K to Rep. Derek Kilmer. Rep. Rick Larsen has requested funds; NARFE is reviewing the request.
- Don said giving, and giving a lot, to NARFE-PAC continues to be important.
