# NARFE CHAPTER 1192 EXECUTIVE BOARD MEETING MINUTES October 5, 2015

President Lorie Bennett called the meeting to order at 12:20 p.m., her home. Besides Lorie, Board members present: Mary Binder; Johanna Caylor; Nancy Crosby; Bill Darke; Steve Howes; Pat Turner. Also attending: Sig Preston. Absent: Bill Darke; Pam Griffin; Larry Williams.

## President/Service Officer/Special Programs: Lorie Bennett.

- Nominating Committee update Pat Turner, chairman and director at large. With the upcoming 2016 May WSFC convention that District V is hosting and the importance of secretarial continuity, Mary Binder agreed to run for another 2-year term. The board discussed having Dana Kranz assist Mary with secretarial duties vs. running for secretary. Pat said she would discuss this with Dana. Pat will present the slate of candidates at the October chapter meeting: Lorie Bennett, president; Pat Turner, 1<sup>st</sup> vice president; Larry Williams, 2<sup>nd</sup> vice president; Mary Binder, secretary; Nancy Crosby, treasurer; and, Steve Howes and Liz Bowers, directors at large. Elections will be at the November chapter meeting. Nominations will be taken from the floor. Sig Preston will conduct the elections. Installation of officers is scheduled for the December meeting.
- FEHBP/Medicare costs for 2016 Lorie made copies of the charts that she will bring to the meeting. NARFE continues to monitor the potential 52-percent increase in Medicare Part B premiums for some retirees. There is proposed legislation in Congress that may resolve the issue. NARFE continues to urge members to contact their elected officials.
- Updated forms Johanna said she has gone through the inventory in the Service Office, tossed out outdated forms, and has a list of the current forms, what the chapter needs, and is ordering those.
- Strategic Planning Committee per Mary Binder and Steve Howes, there have been no recent updates. Further, the August 12 meeting minutes are still not posted to the NARFE website. Mary is maintaining a notebook with all the strategic planning material NARFE is posting to its website.
- Silver Circle Memorial Fund for Don Binder Mary reported that Region IX VP Lanny Ross called September 30 to say \$1,300 had been donated in Don's name. He was sending \$1,000 to NARFE's Silver Circle and \$300 to NARFE-PAC in Don's name.
- Hospitality Lorie has signed the 2016 chapter meeting/lunch contract with the Red Lion Hotel. Menu and lunch costs remain the same as for 2015.
- NARFE is continuing to expand its "member perks." [New items are in the narfe magazine.]

## Secretary/Sunshine/Newsletter/Public Relations: Mary Binder.

- September treasurer's report sent to the board and for posting on the chapter website.
- Nancy said she transferred \$891.59 from the chapter's Umpqua Bank account to the chapter's NARFE Federal Credit Union account. **[Note: New name is** *in***first Federal Credit Union.]** The Umpqua account will remain open and used for the WSFC convention. The \$1,000 from the federation for the convention

has been deposited in that account. Elisabeth M. Bowers was appointed to the treasurer position for the 2016 convention. Her name will be added to the authorized signatures list; Nancy will get the signature cards from Umpqua Bank. Don Binder's name needs to be removed from the account.

 2016 budget – Nancy provided the board the draft and highlighted key changes, especially projected funds to offset costs for members who attend the May federation convention and/or the August NARFE national convention. Nancy will present the draft budget to members at the October chapter meeting. It will be voted on at the November meeting.

**District V Vice President:** Nancy Crosby. Nancy said she will be setting up a separate meeting to deal specifically with the convention.

**Directors at Large:** Steve Howes, Pat Turner. Pat reported that she had been working with NARFE so she could pull up and read OAM reports. At issue – no specific access code for "director at large." The NARFE point of contact identified a code for Pat that now allows for reading access to reports.
