Alzheimer's Research - Larry Williams

NARFE Alzheimer's Research Fund had another good month of fundraising. On top of the Chapter's October Walk to End Alzheimer's amount of \$450 that was reported in the last newsletter, the Chapter held two more events in November. The first was the annual White Elephant fundraiser at the November chapter meeting. That was very successful again this year raising \$2575 in donations and ticket sales. The second event was the annual Tri-Cities Wine Festival where our chapter members staffed the coat check room which raised \$410 in donations. That brings the total to \$3435. A very successful two months!



WSF President - Nancy Crosby

At our December 12 board meeting the 2020 federation budget was discussed and approved. We will not be assessing a \$1.20 per chapter members per capita tax for 2020. We encourage chapters to use their chapter funds to assist members to attend conferences.

"A motion was made and approved to suspend the annual \$1.20 per chapter member per capita tax for year 2020. The per capita assessment will be reviewed annually based on dues funds distribution to the federation."

We were very sad to learn that Mike Ferri, Federation Financial Chairman for many years, passed away. He will be missed.

The Federation Biennial Conference is scheduled for May 19-21, Embassy Suites by Hilton, Seattle North, Lynnwood. The WSF Executive Board has approved a \$50 "scholarship" for each federation member who attends the conference to help offset individual costs. This will be reflected the registration form. Prior to the WSF conference, there will be an election of officers for 2020-2022. Candidates for all 4 elected positions are needed – president, vice president, secretary and treasurer! The WSF Nominating Information and forms are on the WSF website along with an announcement in a future *narfe* magazine.

A reminder about NARFE's biennial national conference, **FEDcon20**, Westin Kierland, Scottsdale, Ariz., August 30 – September 1. The room rate is \$115/plus tax; other details will be on the NARFE website, <u>www.narfe.org</u>, in early 2020

Legislative/Public Relations - Mary Binder

Due to medical issues there will be no report. However, we encourage you all to read the NARFE Bill Tracker in the *narfe* magazine for the information on congressional bills and referendums.

NARFE has issued an "Action Alert!" for the Equal Treatment of Public Servants Act. This act "would reform the Windfall Elimination Provision (WEP) by changing the Social Security benefit calculation for WEP-affected beneficiaries. The WEP harms nearly 2 million local, state and federal retirees by reducing their earned Social Security benefits." Go to NARFE's Legislative Action Center on the NARFE website, www.narfe.org, "to send your members of Congress a personalized message urging them to support the bill 7363 and provide relief for those affected by the WEP." Reminder...squeaky wheels are heard!

Due to illness there will not be a Chapter PAC report. However, the Regional Vice President Rich Wilson reported that 3693 the Washington Federation contributed \$13,022 for an average contribution of \$62.08 for the 3rd Quarter of the 2019-2020 election cycle.

CALLER COORDINATOR REMINDERS!

Chapter "callers" are experiencing numerous wrong numbers when trying to call local members about nonthly meetings. If you haven't been receiving your alls, or if you want to be added to the notification list, lease call me!

Reminder – to guarantee a lunch, reservations MUST be nade by the Sunday evening prior to the meeting. So, if our caller leaves a message, PLEASE return the call, or all me.

The Caller Coordinator relies on the Chapter Callers in performing the above duties. There are 6 Callers, each responsible for calling a portion of the local membership based on the alphabetical listing of members' last names. A week before the meeting, the Coordinator prepares a Notification Letter which is sent via email to each caller. The letter provides information about the meeting date, the scheduled program, and menu items to assist the caller when they are making their calls to the members. The week prior to the meeting, the callers complete their calls to those members who have designated they would like to be called. Members who would like to attend and/or eat lunch, notify the caller of their intent. After completing their calls, the caller emails the coordinator with the names of attendees and luncheon status. After all the callers have responded, the coordinator collects the names and luncheon status and reports it to the board by Sunday afternoon before the meeting. By 10 AM on the Monday before the meeting, the coordinator emails the Red Lion and provides the caterer with the status as to the number of attendees, the number of lunches, and whether any additional equipment will be needed for the meeting. A copy of the email is also provided to the Chapter Board. On an annual basis, in August before the September meeting, the callers contact **all** the members on their listing to confirm that they still want to be called monthly and to verify any other revised calling preferences. These results are provided to the coordinator to update the caller listing for the upcoming year. Also, periodically during the year, the Coordinator is notified about changes in membership status (transfers in and out of Chapter, deaths, non-payment of dues, etc.).and updates the listings and provides the revised listing to the respective caller.
