Service Officer - Ellen LeVee

Now that we are in a new year, there are several things members should consider reviewing, and then making necessary changes, if applicable:

- Medicare Part B Reimbursement. For FEHB plans and options providing at least some level of reimbursement, rather than waiting until the end of the year, members can request the reimbursement as soon as they receive their Social Security statement or other proof that they have Medicare Part B being deducted from an annuity or paid via quarterly statements. Both spouses are eligible to receive reimbursement, provided each has Part B coverage. If just one spouse has Part B, including a non-federal spouse, only that spouse is eligible for the reimbursement.
- Designation of Beneficiaries. Review your information for the Thrift Savings Plan (TSP) and life insurance for beneficiary and/or address changes. The TSP-3 form, Designation of Beneficiary, is no longer available. When TSP changed its website, some of the beneficiaries did not get transferred. To change or check beneficiary information, go to the TSP website. (Life insurance beneficiaries are changed via OPM Services.)
- Complete or review the NARFE F-100 (09/21),

- Be Prepared for Life's Events, What your Survivor's Should Know," or a similar document. The F-100 is NARFE's guide for organizing your personal and financial information. A fillable version is on the NARFE website, www.narfe.org. Also, I have a few printed copies.
- ◆ OPM online services. Your online accounts must be linked with www.login.gov. If you have multiple OPM services online accounts, each login.gov account requires a separate email address. If you have not linked your accounts, this would be a good time to do so. You will then be able to obtain your 1099-R earlier than the mailed copy. Linda Silverio, immediate-past Region IX vice president, compiled information from OPM online services into a tutorial that goes through options for retirees for viewing, printing and making changes. The tutorial is at https://youtu.be/UvLKyoWZHFk.

WSF District I Vice President - Mary Binder

The year ended with a mixture of nostalgia and optimism. I was taken down several "memory lanes" while working through records from closed or closing District I chapters (see below updates); pleased with results from several "outreach" events resulting in several new NARFE members and more visibility for NARFE as an organization; and encouraged by several changes at the Washington State Federation (WSF) level that should be administratively helpful, and include more recognition for chapters' outreach activities and resulting 50-percent matching funds from the WSF back to the respective chapters. For example, Tri-Cities Chapter 1192 received \$545 in these matching funds for 2022, which went back to the chapter's treasury.

Last year started with 6 chapters in WSF's District I. The district covers Eastern Washington. This year we start with 5 chapters, but 2 of those are closing.

To recap: Spokane Chapter 32, Tri-Cities Chapter 1192 and Colville Valley Chapter 1247 are active; Columbia Basin Chapter 856 is officially closed; Wenatchee Chapter 239's closure paperwork is at NARFE headquarters as this newsletter was finalized; and, Yakima Chapter 238 had a special meeting December 8 with a unanimous vote to close the chapter from those who attended the meeting or provided input prior to the meeting. So, the closure process for this chapter has started, too.

While heart-wrenching to see chapters close, it is reality in today's world for many organizations. The GOOD NEWS – MOST chapter members are maintaining their NARFE membership, either in a new chapter or as national-only members. This is key for NARFE's future!

Public Relations - Mary Binder

Where and how to "outreach" to the community about NARFE, with an emphasis on reaching prospective members, remains the primary focus for the chapter's public relations and membership initiatives. In reality, these 2 functions are so linked that we often now just refer to them as "outreach."

Last year was a good "outreach" year for the chapter, resulting in several new members and more visibility with an array of local organizations who are recognizing NARFE as a go-to resource. To note, Ellen LeVee, our chapter service officer, helped several individuals during the recent health benefits season who were referred to her by individuals we'd met at the fall Senior Times Expo.

As noted in President Pat's article, page I, the chapter led the Washington federation in new members for 2022! The federation provides \$25 to chapters for each new member recruited during the year! A check is scheduled to be sent to the chapter in January based on the total number of new members as of December 31. Thank you to everyone who helped in our 2022 outreach efforts.

The chapter's positive recruiting results have caught the attention of other federation chapters, too. In fact, recently, a counterpart from another chapter contacted me and asked for a presentation at a meeting of that chapter about the Tri-Cities chapter's outreach efforts, that is, what are we doing differently!



Legislative - Mary Binder

New year, new 2-year congressional cycle. The 118th Congress, covering 2023/2024, convenes in January.

In the fall, NARFE announced its advocacy positions for the new Congress. Information is on the NARFE website, www.narfe.org. "These positions provide an extensive and specific enumeration of NARFE's member-endorsed positions on legislative and administrative policies and will serve as a guide for NARFE's advocacy endeavors in 2023 and 2024." After logging into the website, click on the "Advocacy" tab, then "Advocacy Update" on the dropdown tab. Go to page 3, and look for "NARFE Announces Its Advocacy Positions for 2023-2024." Also, staying engaged with our elected officials is as important as ever!

The state's 2023 legislative session begins January 9. It is currently scheduled to end April 24. As noted on page 1, Jason Mercier from the Washington Policy Center is scheduled to provide the chapter an update on the session at the chapter's February meeting – always informative!

NARFE-PAC – John Wetterling

In mid-January, the 8th quarter NARFE-PAC results for the 117th Congress should be on the NARFE website.

The 118th Congress, 2023/2024, brings new NARFE-PAC goals. They are on the NARFE
