Legislative/NARFE-PAC - Mary Binder

First, a thank you to John Wetterling for his service as the chapter's PAC coordinator since 2020! He dedicated many hours to reading and analyzing PAC reports and correspondence from NARFE, and then compiling and reporting information at chapter meetings.



Looking ahead, our chapter board has agreed to test combining legislative and NARFE-PAC coordinator duties. This is being done at our Washington State Federation (WSF) level. At NARFE headquarters, too, they both fall under "Advocacy." There is such a close connection between the functions that it makes sense.

As I was asked recently, "What is NARFE-PAC?" I thought it would be good to start the year with a brief tutorial. From NARFE's PAC brochure, "NARFE-PAC is NARFE's political action committee ... it helps defend and advance the earned pay and benefits of America's current and retired civil servants by funding campaigns of Fed-friendly congressional candidates. It is funded "solely by voluntary and direct contributions from NARFE members." NO membership dues or other NARFE non-dues revenue is used for NARFE-PAC. Through the PAC, NARFE builds and strengthens

relationships with lawmakers in Congress so our voices are heard. **It is political but non-partisan.** Again, through the PAC, NARFE provides support to "Fedfriendly" congressional candidates and elected officials.

NARFE-PAC operates on the same 2-year cycle as Congress. So, currently, 2023/2024, which coincides with the 118th Congress. For the 2 years, there are 8 quarters. January 2024 begins the cycle's 5th quarter. NARFE has quarterly reports that recap member contributions and distributions made to candidates. These are at the "Advocacy" tab and then "NARFE-PAC" on the NARFE website, www.narfe.org. (Member login required.)

Contributions are welcome, but especially needed during election years such as 2024. See page 9, January/February NARFE Magazine for contribution information. And, looking ahead – March is NARFE-PAC month. More details at chapter meetings and in the next chapter newsletter.

Now, let's switch to legislation. In the combined January/ February NARFE Magazine, page 6, you will find NARFE's Action Alert: Support Equal COLA Act, H.R. 866/S.3194 for Fair Retirement Security. Passing this legislation would align "FERS COLAs with CSRS and Social Security beneficiary adjustments." It is quick and easy to use the NARFE Legislative Action Center to send a message to our elected leaders asking for their support with this and other legislation. Need assistance? Please contact me.

Also in the January/February NARFE Magazine, pages 8-9, a "progress report" on other "key NARFE legislative campaigns." Included are updates on repealing WEP/GPO and the increase in long-term care insurance premiums.

Lastly – the 60-day, 2024 Washington State Legislative Session begins January 8. Bills not passed last year were retained for this session. A supplemental budget should also be passed. Watch for updates.

Larry Williams, our immediate-past Alzheimer's Research Fund coordinator, reported 2023 was "a good fundraising
