VICE-PRESIDENTS REPORT

(Carl Gallion) **FOOD FOR THOUGHT - AND ACTION!** Our 2006 NARFE National Convention in Albuquerque, NM in September is rapidly approaching. There are some issues that are going to come before that assembly that will affect you in the future. An excel-

lent article is published in the June edition of NARFE *Retirement Life* by past national president Frank Atwater. He talks about the following issues:

Mandatory Chapter Membership (MCM): This issue allows members to elect to belong ONLY to the National organization...and not belong to a chapter. This seems the way to go in light of many of our chapters closing or consolidating. But being a “grass-roots” organization, we need strong chapter involvement to organize and assist members with interactions at local political offices.

One Member-One Vote (OM-OV): Chapters voting at National Convention elections and on National issues vote by qualified “delegates”, a number equal to a percentage of chapter members. This means “all or nothing” voting...no split votes. OM-OV would publish a ballot in the NARFE magazine that is sent to all members current in their dues and voting would be mail-in - thus giving everyone who is a qualified member the power to cast a vote. It can't be more democratic than that!

One Dues Structure: Current management of dues is cumbersome with so many different schedules to consider. If this passes, a single “dues” will be collected by National for everyone to include chapter dues that would be standardized across the whole country. This surely will involve a hefty increase in everyone's dues and give no priority for dues with-

holding, multi-year dues, or CFEs.

YOUR ACTION. You need to think of how you want our delegates to vote. We need to give Johanna and Sig (our delegates at present) our feedback. Send your thoughts to Sig Preston (Sigbo1925@cs.com) and Johanna Caylor (caylorx2@aol.com), or to Chapter President Clark Crouch (clark@crouchnet.com). We are planning a special meeting of the Executive Board in August to air our two eight nine five personal thoughts and help guide Johanna and Sig as they represent us at the upcoming National Convention.

Don spent 37+ years as a federal employee prior to retiring in 1999 and began consulting work. His background is primarily human resources along with several years in emergency management and disaster preparedness. He began his career with Social Security Administration in Baltimore and ended it with the U.S. Army Corps of Engineers in Washington, D.C. However, in between he spent many years in San Francisco and at Fort McCoy, WI. After retirement, he began working as a consultant for the Corps of Engineers in Washington, D.C., and continued in that capacity until the Katrina disaster last year. Since then, he has been back on government rolls in DC. overseeing a new program for the Corps that re-employs federal retirees to help in disaster relief without an offset to their annuity. We expect his work in DC. will continue for at least another year.

Mary Alice recently retired from government service as the public affairs officer at the Army's Umatilla Chemical Depot in Oregon where she's worked for the past 7 ½ years. Her government career began as an elementary teacher at Fort Bragg, NC. Other government teaching assignments took her to: Stuttgart, Germany and San Francisco, CA. where she met Don and made a career change from teaching; Fort McCoy; and, Washington, DC., Pueblo, CO., and finally, Umatilla. OR. While her career covered teaching, human resource work, and a smattering of other assignments, she had worked in public affairs for the Army since 1988.

SERVICE CENTER NEWS (Mary Goldie and Nancy Schreckhise) - National Active and Retired Federal Employees Association (NARFE) President Charles L. Fallis announced today that his organization is unalterably opposed to a proposal sent to Congress this week by the Office of Personnel Management (OPM) for legislation to allow Blue Cross/Blue Shield (BC/BS) to offer Health Savings Accounts (HSA) in the Federal Employees Health Benefits Program (FEHBP).

Section 8903 (1) of Title 5 of the US Code authorizes one government-wide "Service Benefit Plan" to offer two levels of benefits. BC/BS is the Service Benefit Plan. OPM's request follows-up on the President's FY 2007 budget recommendation to Congress that they amend Chapter 89 to allow the Service Benefit Plan to offer three, instead of two, benefit levels which will enable BC/BS to offer an HSA.

"We have been saying since 1995 that these controversial plans are a bad deal for federal employees and retirees of any age who have moderate-to-high health care costs or who are living from paycheck-to-paycheck and cannot afford to pay a high deductible or adequately fund a health savings account," Fallis said. Such concerns

were confirmed by a January 2006 report of the nonpartisan Government Accountability Office (GAO), which found that HSAs tended to attract younger and wealthier FEHBP enrollees. "We believe this trend will continue, and if HSAs become more popular, premiums for comprehensive plans could increase and/or benefits could be cut," Fallis added.

BC/BS's brand loyalty and considerable marketing resources could significantly increase HSA enrollment in FEHBP if they decided, and were allowed, to offer such an option. "NARFE urges Congress to oppose any plan to further expand HSAs in the FEHBP, including the latest legislative proposal OPM has forwarded to them," Fallis concluded.

LEGISLATIVE - NARFE Issues - Why should you care? Mary and I recently finished reading through the July *NARFE Retirement Life* magazine. Several articles and columns struck particular chords with us, so we'd like to share some thoughts and hopefully, bring you up to date on several key retiree issues.

But first, who are we, you may be asking. Good question! *Communication 101* - identify yourself; let your au-

dience know something about you. Therefore, we'd like to introduce ourselves to you, our reading audience, in the sidebar article on Page 2. OK, now that introductions have been made, let's talk issues. Wait, hold on, don't stop reading yet or start thinking this is too complex for me, I'm on summer vacation, this doesn't pertain to me, I've heard all this before, I'm just one voice what can I do, etc. Hang in there with us for just a few minutes.

If you don't think one voice, one vote can make a difference, reflect back for a minute on the difference one, yes, one vote made many, many, MANY years ago on whether English or French would be this country's national language. So yes, your voice, your vote can make a difference.

If you attend chapter meetings and/or read the monthly *NARFE Retirement Life* publications, you know there are two major legislative issues NARFE is following - Premium Conversion and Social Security Offsets. We expect both to be topics of discussion at the upcoming NARFE 2006 National Convention in Albuquerque, N.M., Sept. 9 - 14.

Premium Conversion - what is it and why should you care? House Resolution (H.R.) 994 would allow civilian and military retirees to pay health care premiums with pre-tax dollars as Members of Congress, their staffs and all federal employees can do. Let's use Mary as an example. *As a current federal employee* she was paying about \$100 a month for medical insurance through the Federal Employees' Health Benefits Program. Multiply that by 12 months and you get \$1,200 - all of which was *non-taxable income*. *As a retiree, it is taxable income!* A big difference - making less but paying more, proportionately, in taxes, is an issue for many people, including our NARFE leadership. Recently, Rep. Doc Hastings became a "cosponsor" of **H.R. 994**. Both Washington Senators Patty Murray and Marie Cantwell are also cosponsors. While this does not guarantee they will ultimately vote in support of the proposed resolution, it is at least a step toward gaining their votes. NARFE leadership is asking members to help ensure elected officials such as Senators Murray and Cantwell and Representative Hastings continue to support this initiative by contacting them and asking them for their continued support.

The other major legislative initiative NARFE is working is Social Security Offsets. There are two issues NARFE is supporting - repealing or amending the Social Security Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP). The July *NARFE Retirement Life*, has an excellent 4-page pullout section devoted to these issues, with good, easy-to-understand information and examples. We encourage you to read this pullout if you have not already done so. As stated in the magazine, the pages are designed to be taken out, copied and shared. *Regarding GPO* - as the pullout states, "Present law prevents many federal, state and local government retirees who were first eligible to retire in December 1982 and later from collecting both a federal annuity based on their own work and Social (Cont. on Pg. 5)

(Continued from Page 3) Security benefits based on their spouse's work record. There are approximately 335,000 beneficiaries currently affected by the GPO, and that number grows by about 15,000 annually." Note, this law can affect federal, state and local government retirees. Regarding the WEP - again, as the pullout states, "Current Social Security law includes a provision that greatly reduces the Social Security benefit of a retired or disabled worker who also receives a federal, state or local government annuity based on his/her own earnings. There are approximately 755,000 beneficiaries currently affected by the WEP, and that number grows by about 60,000 annually." Once again, this law can affect federal, state and local government retirees. As the July NARFE - *Retirement Life* states, "one of NARFE's top legislative goals is to ensure fair Social Security benefits for government retirees." Yes, there is a cost, and "NARFE members must be aware that this corrective legislation carries a price tag." If you contact a member of Congress, note the information provided on Page 35 in the pullout.

We are also watching with interest each month's consumer price index figures, which will ultimately determine federal government retirees 2007 COLA - Cost of Living Adjustment. Simply put - your "pay raise" effective January 2007. As of the end of May, the index - the difference between the third quarter average for 2005 and 2006 - was 2.9 percent. This is a significant difference from the figures we've seen in the past few years. It reflects the cost of living increases - gasoline prices alone have certainly gone up, as just one example! The 2.9 percent difference will most likely change between now and the end of September - the end of the government's fiscal year. Stay tuned; we are.

So, what does all this mean to you, to our NARFE chapter here in Eastern Washington? The obvious, of course - these issues can directly affect your pocket book, your quality of life. But in an even bigger picture, they can ultimately affect who is attracted to government service - whether federal, state or local - or who ultimately decides to stay and make government work a career vs. a temporary job and merely a stop in a career path. Therefore, we encourage you to continue to watch, listen, read and ask questions. Remaining involved is KEY. Remember, if all of our individual voices are working together as an effective group, we will be heard. Our elected legislators are a phone call or an e-mail message away. Calling Maria Cantwell's or Doc Hasting's local offices, for example, and asking for their support is truly just a phone call. (Note: Due to security issues since 9/11, sending letters or post cards is discouraged.) This is not the time to say, I don't write well, I don't know the issues well enough to voice an opinion, I'll leave the calling or writing to someone else. If we want to maintain our benefits, if we want "fairness" as NARFE leadership has stated, if we want to continue to attract young people to government service, *we all must continue to care and work toward that end.*
