Looking ahead to fall and the re-starting of our Chapter's monthly meetings. It may be a time for all of us to re-evaluate priorities and decide which efforts and activities we will engage in that bring us purpose. Purpose – it's difficult to commit to activities that don't bring fulfillment. Key NARFE issues and points:

- Recruiting and retaining *NARFE* members nationwide is critical to *NARFE*'s future – less than 1% of *NARFE* members recruit even 1 new member a year
- Upcoming changes – 3 of the 4 national officers and 5 of the 10 regional VPs will be elected at the upcoming *NARFE* convention

Key Washington Federation issues and points:

- Convene WSFC conventions every 2 years vs. annually beginning in 2012
- Now 2-year terms vs. 1 year for Federation officers and district VPs with a maximum of 2, 2-year terms
- Resolution passed calling 6453 for a national single dues proposal
- Approved bylaws and standing rules are on the WSFC web site, www.narfewa.net
- Convention participants donated \$1155 for *NARFE*-PAC; \$298 was raised for Alzheimer's research from drawings and other solicitations

31st NARFE National Convention, August 29 – September 2. Chapter members Johanna Caylor and Sig Preston are planning to attend and represent the Chapter. Our Executive Board is scheduled to meet August 11. Agenda items include reviewing resolutions submitted for the Convention, the election of *NARFE* officers, and how our Chapter's votes will be cast. The Board welcomes your comments! With the election season definitely in full swing, politicians are submitting requests for PAC funds to help their election campaigns. Why should NARFE support these 5496 requests? I think Lanny Ross, our Region IX VP, summed it up best at the Federations' recent annual convention:

"NARFE's mission is legislation – to maintain our earned benefits. Without a PAC, NARFE is not competitive, in the fold with other organizations on Capitol Hill. NARFE does not buy votes; but, through the PAC process, NARFE can open Congressional doors so Congress knows who we are and our concerns, and so we can be a viable force. Federal employees and retirees are a target at this time with red ink in DC. Retirees' annuity is part of a 'contract.' It is important that Congress understands it is a contract [not a target]."
