The recent Washington State Federation of Chapters convention was the first official NARFE event I have attended outside of chapter meetings and one district training program. I found it to be informative; and, it was reassuring to me to learn that we have some

highly skilled and knowledgeable people looking out for our interests at the national level.

Jessica Klement, NARFE legislative director, gave an excellent update on her staff's recent activities on our behalf. She spoke to the importance of PAC in achieving our goals. She likened NARFE's mission to a 3-legged stool in which lobbying Congress, grassroots advocacy, and NARFE-PAC all play different but equally important roles in protecting our rights and benefits. If one leg is weak or collapses, then NARFE becomes ineffective, and our benefits and other issues important to the current and retired federal work force are in jeopardy.

Jessica and her team are providing NARFE members a wealth of information, and in a variety of formats. As Chapter President Lorie Bennett wrote in her article, she is working to stay in touch even while on the road this summer as it is important to do so. We are just living in a time when, more than ever, things are changing, and often very quickly, whether on the local, state, federal, national or international level.

So, some information and reminders:

- ◆ August 2, state primary! Ballots will be out around mid July, and will include everything from candidates running for our district's U.S. House of Representatives seat to local initiatives. **Yes, your vote counts!**
- ◆ Pasco was recently chosen as 1 of 5 debate sites for either the U.S. Senate or the governor's race. Exact date and race will be announced later this summer. To note, the current U.S. Senate has 54 Republicans and 45 Democrats, including one independent. There are 34 seats up in 2016 of which 24 are held by Republicans. Democrats would need to gain 4 or 5 seats to take control.
- ◆ At the state level, besides elections, state budgets issues will continue to be front and center.

- ◆ Last year's OPM data breach is still in the news. NARFE continues to have updated information on its website, [www.narfe.org](http://www.narfe.org).
- ◆ "Tiny rise" in Social Security is possible for 2017.
- ◆ Acting on NARFE's calls to action is critical!

- ◆ Sign in as a member on the NARFE website.
- ◆ On the homepage, click Departments, Legislation, Legislative Action Center, Contact Congress.
- ◆ Enter your ZIP or ZIP+4 Code, then click Go.
- ◆ Select an "issue" under Take Action.
- ◆ Complete your contact information.
- ◆ Click Go to Letter.
- ◆ Select the letter you want to send.
- ◆ Click Submit.

That's it! It is that easy, it is free, and so important!

## IRS Consumer Alert

(IR-2016-89)

The IRS recently published good-giving practices as a reminder to taxpayers. It covers 4 specific areas: 1) Giving to **recognized charities** with long-standing, good reputations; 2) Phantom charities with **similar names** to the respected charities; 3) Not giving **personal information** over the phone, e.g., SSN, credit and bank numbers; and, 4) Generally avoiding giving **cash gifts**. (Note: IRS Publication 526, *Charitable Contributions*, has more details.)
