"Busy" continues to be a good word for Washington State Federation-level (WSF) activities, although officers and coordinators are trying to balance those with summer activities, too. Virtual

meetings continue as officers and coordinators work on several projects, everything from strategic planning to updating position descriptions and policies and procedures, to planning the federation's annual meeting (virtual) in September to an in-person federation conference in October 2024! So, a few updates for you.

In June there were 2 statewide postal conventions – the Washington state Rural Letter Carriers Association (WARLCA) and the United Postmasters and Managers of America (UPMA) – where we had a NARFE table and at which I was able to make a presentation about NARFE. The WARLCA convention was in Silverdale; the UPMA convention was at the Clover Island Inn, Kennewick. I am pleased to report that between the 2 conventions there are 15 either new and/or reinstated NARFE members, and we have been invited to attend their next conventions! A special thank you to Membership Coordinator Johanna Caylor and member Janice Lake for their help with the UPMA convention!

Both Wenatchee Chapter 239 and Yakima Chapter 238 are now officially closed. While it is disheartening to have to close chapters, I am encouraged that most of those chapters' members are continuing their NARFE membership either as national-only members or as members of different chapters, including the Tri-Cities chapter. With these closures, there are now just 3 remaining chapters in Eastern Washington: Spokane Chapter 32; Colville Valley Chapter 1247, and Tri-Cities Chapter 1192. August is NARFE Grassroots Advocacy Month. Typically, our U.S. representatives and senators are home for an extended period of time so it is a great opportunity to reach out to them. More details will be in the August NARFE Magazine and electronically from NARFE.

To note, at **LEGcon23**, attendees were asked to focus on 3 "asks" when meeting with our elected officials:

- H.R. 82/S. 597, Social Security Fairness Act, which is the repeal of "the evil twins," GPO and WEP.
- H.R. 866, the Equal COLA Act, which would provide full COLAS to FERS employees and retirees.
- Protecting earned benefits from cuts.

NARFE-PAC - John Wetterlilng

The second quarter PAC reports for the 118th Congress, April I through June 30, should be posted on the NARFE website by around mid-July. There will also be summary information at the September chapter meeting.

I was recently asked, "What is NARFE-PAC?" This made me think that sometimes we use terms and/or talk about programs and forget not everyone knows what we are talking about. So, a good reminder for me!

NARFE's "political action committee" (PAC) is its political but nonpartisan "arm" that works to protect NARFE members' pay and benefits by raising and spending money to elect members of Congress who support the federal community." The "PAC" works for us "by building strong relationships with lawmakers and providing NARFE with additional opportunities to share our most pressing concerns." It is "financed through NARFE members' direct, voluntary contributions to a separate fund. Federal law prohibits NARFE-PAC from soliciting contributions from anyone other than NARFE members and the immediate family of these individuals."
