

through NARFE's Legislative Action Center is quick and easy. Writing letters with personal examples of how you have been/are impacted by a piece of legislation also helps. And of course, vote ... to help elect officials who support the federal community!

There are 2 recent examples of how such "advocacy" can create positive results. The repeal of the GPO/WEP laws with the passage of H.R.82, Social Security Fairness Act, in late 2024 and then President Biden signing the repeal into law in early January, is an excellent example. After more than 40 years of working on the repeal, it is now reality!

Then, too, the final version of H.R.I, The Big Beautiful Bill, passed by the Senate contained "... no federal workforce provisions opposed by NARFE." NARFE National President William "Bill" Shackelford recently issued a statement saying, "This represents a huge victory for NARFE and its members in a year-long effort to oppose – and ultimately block – passage of objectionable federal workforce provisions ... During this process, approximately 7,962 NARFE supporters wrote 35,809 messages to lawmakers in opposition to H.R.I. This is testament to our concerned and engaged federal community ready to defend its pay, benefits and rights." Engagement works! Thank you to all who participated.

There is another key component in helping NARFE staff in helping us –

NARFE-PAC. Contributions help maximize the federal community's influence by pooling NARFE members' contributions so federal workers' and retirees' interests are first. Thank you to all who have and/or are contributing! Please know contributions are still very much needed!

For members who were not at the June chapter meeting, I reported that May was an "exciting"



month for your chapter treasurer! Gesa Credit Union closed our account as Washington state requires us to have a business license to bank there. For an annual fee of \$55, we now have the license and are "back in business" with Gesa! I was then able to pay the chapter's bills and move \$15K into a 9-month CD with a 4.4% APY (Annual Percentage Yield). At the beginning of July, the chapter had \$20,308 in its Gesa Credit Union accounts. Bills are paid, and additional stamps purchased prior to the 5-cent increase July 13! If you need more details on the chapter's finances, please contact me.

Looking ahead -2 things. As I've previously written, printing and mailing newsletters is our biggest expense. If you receive a mailed copy, please consider changing to an electronic copy, if that can work for you. Let Service Officer Nancy Crosby know if you can make the change. Second, before too long, I will be starting work on the chapter's 2026 budget. If you have questions, need more information and/or have input, please let me know.

Membership Chairman - Johanna Caylor

As of July 6, our chapter had **483** members – **218**/chapter; **265**/national-only in the chapter area. This is an overall drop of 2 members since my last report. (The number of chapter members decreased but increased for national-only members.) I continue working on getting dropped members back!
