I attended the Washington State Federation of Chapters (WSFC) board meeting in Tacoma, February 7. Besides the officer, district and chairmen reports, there was discussion on the March NARFE Legislative Training Conference in D.C. We'll have representatives from across our state attending, including several from our district, and Mary and Don Binder from our chapter.

The agenda for the first Region IX
Leadership Training Workshop,
May 31– June 1, is being finalized
and will include training sessions that
will benefit all chapter members, not just NARFE
"leaders." I encourage our newer members to attend
as this will be an informative training session. A flyer
and the registration form are on the federation's
website, narfewa.org, and will be at our chapter
meetings. Chapter 1192 will reimburse its members
attending the workshop the \$30 registration fee.

Finally, OPM has provided an update to the message on the back of the annual COLA notice members received in late December regarding future Forms 1099R being available only electronically. OPM has since informed NARFE it will provide instructions this year to annuitants on how they can "opt in" to receive their 1099s electronically. However, members choosing to not "opt in" will have their 1009R mailed to them.

As most members know, NARFE reached its \$10M goal for Alzheimer's Research in November. Following this milestone, Alzheimer's Association President Harry Johns said, "For more than 25 years, NARFE has demonstrated steadfast commitment to the mission of the Alzheimer's Association." Based on our giving record, NARFE is now a member of the Alzheimer's Association's distinguished donor program, the Zenith Fellows. Our new goal is \$11M in total contributions by the end of 2014.

Remember! Yes, 100% of NARFE Alzheimer's donations go directly to support Alzheimer's research. To date, NARFE has funded 56 Alzheimer's research grants. So far this year, Chapter 1192 leads all Washington federation chapters in contributions with \$1,185. Thanks again for your support.

Washington State is one of 4 key states working extra hard to impact the thinking on Capitol Hill. Why Washington? Senator Murray is now in the key position of chairing the Senate Budget Committee. Along with its counterpart in the House, this committee has responsibility to draft Congress' annual budget plan and monitor its action for the federal government. As chair, Senator Murray is the leader in this initiative. Even though the Senate has not passed a budget in more than 3 years, upon assuming the role of chair, Senator Murray promised to do so.

NARFE has drafted a letter to Senator Murray that is posted on our chapter website. If you print and sign the letter, or better still, write your own letter, and get it/them to us by March 7, we will personally take them as a group to Washington, DC.

As we have for the past 3 times, we and several others from Washington chapters, will attend the National Legislative Training Conference, March 9–12. The last day we actually go to Capitol Hill to meet with senators, representatives and/or staff. Thus, we'd like to have those letters to take at that time.
