**Chapter President – Pat Turner**


This is my second newsletter article as your chapter president. I would like to thank the chapter board members for their support and chapter members for your confidence in me.

These are busy months for our WSF – Washington State Federation! First, the election for officers. We have candidates for each federation elected office. The election ballot is available on the WSF website, [www.narfewa.org](http://www.narfewa.org). Ballots must be submitted by **March 31**. If you do not have access to the website, **please** contact me and I will send you a paper ballot. (Note: There will be paper ballots at the March 4 chapter meeting.)

Next, conferences! There are 2 this year, one here in Washington, the other in Arizona. I hope you are considering attending one or both!

First, the WSF biennial conference is May 19-21, Embassy Suites by Hilton, Lynnwood. The hotel reservation information is on the WSF website.

The cost is \$113 per night plus taxes, and includes breakfast and a social hour for registered hotel guests. The conference registration forms and agenda will be on the WSF website soon. Registration is \$127 but federation members will only pay \$77 as the federation is paying a \$50 “scholarship” for each federation member who registers. ### Public Relations – Mary Binder

The 2020 U.S. census is upon us! Did you know that “in the 2010 census, Benton and Franklin Counties were **undercounted by nearly 30%** or 75,000+ people. Each uncounted person is a **loss of \$2,300 per person** each year for 10 years affecting 130+ Federal programs including: Medicaid, Head Start, housing and food for low income families, public transportation, college student loans, highway planning and construction, children’s health insurance and public school funding.”



Census reminders! **“Your 2020 Census responses are safe and secure and protected by law.** The Census Bureau will never ask for your Social Security number, money, to come into your home, for your bank or credit card account number, your mother’s maiden name or threaten you with arrest if you do not comply. You can respond **online**, by **mail** or by **phone**. Answering the 10 questions will take less than 10 minutes.”

Here is what to expect in your mailbox:

- ◆ March 12-20 – An invitation to respond online to the 2020 Census (Some households also will receive paper questionnaires.)
- ◆ March 16-24 – A reminder letter.
- ◆ March 26-April 3 – A reminder postcard.
- ◆ April 8-16 – A reminder letter and a paper questionnaire.
- ◆ April 20-27 – A final reminder postcard before the U.S. Census Bureau follows up in person.

## Legislative – Mary Binder

Election season is definitely here. The Washington State Presidential Primary is March 10 – a change from past years when it has been in May. Another change, per Secretary of State Kim Wyman, “... the major political



parties require voters to choose a party in order to participate in the nomination process. Your choice of party will **not affect** how you may vote in future elections. You must mark and sign the political party declaration (box) on your envelope for your vote to count per RCW 29A.56.050 ... In the November General Election, you will not declare a party and may vote for any Presidential candidate you wish.” Having to choose a party for the March 10 primary has been controversial for several reasons. So, it will be interesting to see what the voter turnout will be as a result. If the change is one you do not support, you need to voice your objection to our legislators.

Speaking of contacting our legislators, it is definitely not too late for a 2020 “resolution” to commit to contacting our legislators regarding issues NARFE’s Advocacy Department is working on for us. Whether it is “WEP” or “GPO” (several bills) or the USPS Fairness Act, H.R. 2382/S.2965, the NARFE staff needs grassroots support from NARFE members!

As a reminder, here are 2 NARFE legislative resources: the NARFE NewsLine and the Legislative Action Center. The NewsLine is “a weekly newsletter that goes out to NARFE members on Tuesdays and includes weekly recaps of legislative news, compiled by NARFE’s advocacy and communications teams.” The Action Center is a “one-stop site to send a letter to Congress and more, at [www.narfe.org](http://www.narfe.org).”
