

Chapter officer elections will be in the fall. Current officers (president, vice president, secretary, treasurer) are either serving their second, 2-year consecutive term or are




continuing to serve as there was not a replacement candidate at the last election. So, I encourage you to learn more about the positions and responsibilities, and then step up and volunteer to serve.

Informational note: **OPM** <u>randomly</u> requests a notarized verification/proof of life from federal annuitants (age 90 and over) receiving annuities to help protect the integrity of payments. If you receive such a request from OPM-RES Fraud Branch, Washington, D.C., please DO NOT IGNORE IT. Your annuity could be suspended if you do.

It has been a busy winter for the WSF (Washington State Federation) elected officers and appointed coordinators. Between virtual meetings, several in-person visits at

chapter meetings, emails, phone conversations, etc., leaders are learning more about NARFE and our WSF, operations and policies and



procedures are being reviewed, etc., all with a goal of keeping our federation alive and vibrant.

But, these are challenging times, including at NARFE headquarters as there are currently several position vacancies. An example – processing chapter closure paperwork is on hold due to a vacancy. Locally, this has affected closing Wenatchee Chapter 239 and Yakima Chapter 238. As I previously wrote, the GOOD NEWS is - MOST chapter members are keeping their NARFE membership. This is key to NARFE's future!

As reported elsewhere in this newsletter, last year was a good "outreach" year for the chapter that resulted in several new members. These public relations and membership efforts also provided more visibility with several local organizations who are recognizing NARFE as a go-to resource. Congress is scheduled to be in the March NARFE Magazine. From NARFE, "Bills from the previous Congress that were not enacted must be reintroduced and given a new bill number ... NARFE will use the Bill Tracker to provide monthly updates on legislation important to the federal community throughout the I18th Congress." An example of a reintroduced bill is the Equal COLA Act.

• Finally, yes, staying engaged with our elected officials is and will continue to be as important as ever!

The state's 2023 legislative session began January 9. It is currently scheduled to end April 24. Jason Mercier from the Washington Policy Center provided an overview at the February chapter meeting. Missed his presentation? There is a
