At the February chapter meeting, I reported that at the November chapter meeting we will elect new chapter officers – president, vice president, secretary, treasurer – for 2026/2027. I will be chairing a nominating committee and need volunteers to assist me in reaching out to our

ELECTIONS AHEAD

Chapter President Duties

(NARFE Chapter and Federation Officers Manual, F-10)

- Presides at chapter and executive committee meetings, conducting business in an orderly, impartial manner.
- Ensures at least a portion of chapter meetings focuses on NARFE's mission.
- Is familiar with NARFE's organization structure, national bylaws, the chapter and federation bylaws, policies and procedures at all levels and Robert's Rules of Order Newly Revised.
- Appoints standing and special committees, as needed.
- Working with the treasurer, ensures the IRS Form 990N (e-postcard) is filed electronically annually by May 15.
- Ensures officers/coordinators have the appropriate information to fulfill the duties of their position and follows up to ensure they are operating effectively.

Other duties as needed or requested:

- Prepares and distributes meeting agendas.
- Represents the chapter within the Washington State Federation and Region IX.

Speaking of stepping up, a special thank you to member

Laney Kruschke for volunteering to coordinate a chapter group activity - attending a Dust Devils baseball game Saturday, May 31, with "Bully Pen" seating and a BBO. We need 25 attendees to cover the cost, which is \$30/ per person. Cost is payable to

Chapter Vice President Duties (NARFE Chapter and Federation Officers Manual, F-10)

So, with all that is happening, it is more important than ever to stay actively engaged with our elected officials! A key tool for NARFE to do this is its NARFE-PAC. "The PAC works for you by building strong relationships with law-makers and providing NARFE with additional opportunities to share our most pressing concerns," per information on the NARFE website. Further, "NARFE-PAC is financed through NARFE members' direct, voluntary contributions to a separate fund. Federal law prohibits NARFE-PAC from soliciting contributions from anyone other than NARFE members and the immediate family of these individuals."

MARCH IS NARFE-PAC MONTH!

While contributions are welcome any time, during March there is particular emphasis on NARFE-PAC. You will find information in the March NARFE Magazine, on the NARFE website, and in electronic updates throughout the month. To note, NARFE Region IX (Alaska, Idaho, Montana, Oregon and Washington) has a long history of strong support to NARFE-PAC! For example, for many years, the region has led NARFE's 10 regions in "mean average." So, please consider a contribution, or an extra one, in March. You can do so online via the NARFE website or through the form in the March magazine. Thank you!

Looking ahead – the dates for **LEGcon25** are June 9-11. This is NARFE's biennial legislative training conference. It is held during the early months of a 2-year congressional cycle. The event will be virtual so the only cost will be registration, which is still to be determined.
