#### Director at Large - Steve Howes

Many of us who have retired from federal service spent our entire federal working careers with a single agency or department. Although we all were (or are) part of the same workforce, missions differ significantly among governmental departments and agencies. Very seldom do we have the opportunity to learn more about what colleagues in other federal agencies do and the services they provide.

February 24, 12 members of Chapter 1192, along

with a few friends and spouses, had just such an opportunity when U.S. Fish and Wildlife Service employees hosted us for a tour of the McNary National



Wildlife Refuge, headquartered in Burbank, Wash.

Our group met at the visitor center where we were briefed on the history and mission of the National Wildlife Refuge system, in general, and the McNary refuge, in particular. Lamont Glass, refuge manager, explained that the McNary refuge was established in the mid-1950s to help mitigate loss of waterfowl habitat on the Columbia River resulting from construction of the McNary Dam.

While the refuge's primary mission is to manage habitat for migrating waterfowl such as ducks, geese and swans, it also provides habitat for a variety of birds of prey, songbirds, shorebirds, mammals and reptiles. The refuge promotes environmental educational opportunities for local schools and other interested groups. While this effort is sponsored and supported by the U.S. Fish and Wildlife Service, it is staffed primarily by a dedicated group of volunteers.

Following our briefing, the group boarded vans for a field tour through the refuge. We observed results of a recent prescribed burn to remove unwanted vegetation and increase shoreline accessibility for waterfowl. We also saw co-operative farm fields where a portion of each harvest, primarily corn, is left for birds. Finally, we saw the new pond and drainage construction in the Walla Walla River Floodplain. Hopefully, these new improvements will provide much needed wildlife habitat for the future.

A trip highlight was watching a large flock of about 10,000 snow geese move from the farm fields to one of the ponds. It was quite a sight that will not be soon forgotten by those who were there.

Yes, it was a good trip. If you have ideas for other future chapter trips, let me, or another chapter board member, know. As to what's next? See below!

#### Alzheimer's Research – William Darke

NARFE has now raised more than \$11,700,000 toward Alzheimer's research since 1985. The current goal is to raise at least \$12 million by the end of 2016. We're close!

Members attending the 2014 NARFE National Convention in Orlando voted to establish the current goal. It will be interesting to watch whether the goal is again increased at this year's national convention.

On the home front, at our April chapter meeting, we received \$23.00, which brought our Alzheimer's account balance to \$172.00. I sent a check for \$144.00 to the federation Alzheimer's chairman, reducing our account balance to \$28. [A reminder: a small amount is maintained in the chapter's Alzheimer's account to keep it open.]

The Alzheimer's fundraising fiscal year for our federation is May through April. So, our 2015/2016 year ends each April 30 and a new year begins May I. For the year ending, our chapter members contributed \$2,500.00 to the NARFE Alzheimer's Research Fund – our second highest funding total! Thanks to everyone who contributed.

A final reminder – by contributing to the NARFE Alzheimer's Research Fund, you ensure that your entire contribution goes for research rather than having a portion go for overhead. This is per the agreement NARFE has with the Alzheimer's Association. Also, if you itemize on your tax return, donations to the NARFE Alzheimer's Research Fund are tax deductible. **620s6**

# ANNOUNCEMENT! OPEN SEASON FOR FEDERAL EMPLOYEES GROUP LIFE INSURANCE

#### September 1 to September 30

The last FEGLI open season was in 2004 ... In 2016, due to the change in premiums [in January], there will be another open-enrollment period. Employees won't have to prove insurability or have experienced a particular life event to participate in this rare open season. Retirees won't be eligible to take advantage of the open season. (Both employees and retirees can decrease their life insurance at any time and there are circumstances under which employees can increase their FEGLI coverage without an open-enrollment event.)

Increases in insurance coverage made during open season will take effect at the beginning of the first pay period on or after October 1, 2017.

# Legislative – Mary Binder

As President Lorie Bennett wrote in her article, page I, it will be a busy summer. Steve Howes, our chapter NARFE-PAC chairman, echoes this in his article below. Further, at chapter meetings, President Lorie has continued to encourage members to send letters to our elected officials, especially for legislation NARFE supports pertaining to our benefits as either current or retired federal employees. Two examples are: H.R. 711, a bill that while not eliminating the long-fought Windfall Elimination Provision, would at least reduce the amount of money Social Security penalizes federal annuitants; and, S. 2699 and H.R. 4585, pertaining to "Federal Adjustment Income Rates." The Senate bill supports a 5.3 percent pay raise in 2017; the House bill supports a 3.9 percent raise. More details are in *narfe* magazines.

So, repeating from our last newsletter, here are the "how-to" steps for using the NARFE letter option:

- Sign in as a member on the NARFE website.
- On the homepage, click Departments, Legislation, Legislative Action Center, Contact Congress.
- Enter your ZIP or ZIP+4 Code, then click Go.
- Select an "issue" under Take Action.
- Complete your contact information.
- Click Go to Letter.
- Select the letter you want to send.
- Click Submit.

That's it! It is that easy! It is free! And, it is that important, especially with all that is happening.

# NARFE-PAC – Steve Howes

The election season is currently in full swing; and, if you watch any of the cable news networks, all you seem to hear about are the presidential primaries, delegate counts, which candidate said what and to what effect, and what may happen if a particular candidate is elected in November. There has been much discussion by candidates of both parties dealing with immigration, the national debt, foreign policy, the economy, military strength, and the role of the federal government. It is often difficult for individual voters to make sense of it all and to separate reality from political theater. As active or retired federal employees, we may feel uncertain about potential impacts the upcoming elections could have on our earned rights and benefits. One thing you can be sure of, I believe, is that federal employees and retirees will once again be in the crosshairs when future battles over the budget are waged.

That is where NARFE "has our backs." Regardless of who becomes the next president, Americans will also elect 34 senators and 435 representatives in November. To make good on campaign promises, the president will have to deal with Congress.
