WSFC District V VP - Mary Binder

Following up on WSFC President Nancy Crosby's article, above, I am pleased to report that all 3 WSFC District V chapters will have members attending the Region IX Training Conference! Further, 2 of the district's 3 chapters now have outreach action plans in place – something that, to the best of my knowledge, is unique to District V.

As I previously wrote, these outreach plans are roadmaps for a chapter's public relations and membership activities for the year.



Further, the federation reimburses the chapter up to 50 percent for some outreach costs, if they are on the approved plan and reimbursement paperwork is submitted. This is a win-win for chapters!

For those newer NARFE members, the Washington State Federation of Chapters has 20 chapters throughout the state, grouped into 5 districts. District V has 3 chapters – Tri-Cities Chapter 1192; Walla Walla Chapter 237; and, Yakima Chapter 238.

Alzheimer's Research - Bill Darke

The Washington federation's Alzheimer's funding year ended April 30. For the year, the chapter contributed \$2,468.38 for the NARFE Alzheimer's Research Fund! This was the 4th consecutive year the chapter exceeded the \$2,000 level.

Your contributions also helped toward NARFE exceeding its \$12 million goal by the end of 2016. The new NARFE goal is \$13 million by the end of 2018.

So, thank you to all who contributed for your outstanding support during this past year. We are certainly doing our part toward defeating this terrible disease.



Legislative - Mary Binder

"Last year was spring training; this [congressional] session will be the regular season," said NARFE President Dick Thissen in his opening remarks at the March 2017 NARFE Legislative Training Conference. He went on to say that we need to be "prepared for the biggest fight in decades." 3550

Regarding earned benefits, President Thissen said to members, "Remember, you earned this; don't let anyone tell you otherwise." He also reminded members that "the glue that holds the federal government together and makes America work is the federal employee." So, "speak with pride of your work, don't be apologetic ... be proud; stand proud."



With May 7-13 as 2017 Public Service Recognition Week, President's Thissen remarks are even more on target. Also at the conference, Cliff Johnson from National Journal noted a shift away from "D.C. advocacy" to grassroots. Regarding advocacy, he said we "need to be in it for the long haul."

Johnson also provided 3 easy-to-understand but very important points for being a strong advocate. First, and most importantly, "show up," meaning, attend public meetings, send letters, make calls. Second, "be visible." If you attend a public meeting, for example, ensure you ask a question/make your presence known. And, third, "be prepared." NARFE can definitely help with this as it is a great resource for everything from white papers to statistical information.

As Johnson said in concluding his presentation, "We have government by the majority who show up." Or, the squeaky wheel gets heard!

Speaking of showing up, President Lorie and Leon Bennett joined me at the Veterans Service Fair, April I, at CBC hosted by our congressional district representative, Dan Newhouse. NARFE/ our chapter was invited to participate

along with more than 30 other agencies. Besides the opportunity to talk with veterans, some of whom were looking for jobs in the federal government, it was a great opportunity to meet and interface

I am pleased to report that through March 3I, the end of the first quarter in the 2017-2018 collection cycle, Chapter 1192 members had contributed \$368 to NARFE-PAC. Of that, \$83 was contributed at chapter meetings. Also, I received another \$224 in April!

In reviewing the first quarter NARFE-PAC reports, our Tri-Cities chapter ranked 10th of the 20 Washington chapters in contributions BUT 1st in the number of sustainers with 6! Let's continue that ranking with even more sustainers! But, all contributions welcome!!

While you've probably heard this before, NARFE-PAC contributions do go to good use. They are door openers in NARFE's work with our elected officials. They help support elections/re-elections for representatives and senators who ask for PAC dollars AND who support NARFE's issues.

Issues – there are many we are facing in the 115th Congress. NARFE has a handout titled "Budget Threats to Federal Employees and Retirees in the 115th Congress." Included in the "threats" are: a reduction in the government's contributions to our health insurance; reducing benefits for current employees; eliminating FERS for new hires. Stay tuned. We'll work to keep you posted.

Yes, now more than ever, NARFE-PAC contributions are vital in combating these threats and more.
