The WSF Advisory Committee – the elected officers, and our appointed chairmen and coordinators – had a virtual meeting April 8. It was open to all WSF members, whether chapter or national-only. Minutes and meeting reports will be posted on the federation website, [www.narfewa.org](http://www.narfewa.org). A few highlights and reminders:

- ◆ **FEDcon22**, the biennial NARFE conference, will be August 21-23, Westin Kierland, Scottsdale, Ariz. [See the NARFE website and/or pages 42-43, May *NARFE Magazine*, for details.] The Advisory Committee approved “scholarships” for WSF members in good standing who attend the conference and submit the WSF F-I reimbursement form and relevant receipts. This includes the \$190 early-bird registration, up to that amount for later registrations, and also up to \$750 for airfare, hotel and other related out-of-pocket expenses. I hope these “scholarships” encourage WSF members to attend!
- ◆ NARFE national officer elections will take place this year. Candidate statements are in the May *NARFE Magazine*, pages 44-52. I announced at the WSF Advisory Committee meeting that I am a candidate for the Region IX VP position that Linda Silverio is currently holding. She previously announced that she will be moving out of the region after her term expires December 31. Watch for voting details in future *NARFE Magazines*, on the NARFE website and via other announcements. Remember to vote.
- ◆ Our WSF annual meeting and conference will be virtual, October 10-14. **NOTE!** These will not be full-day sessions! The agenda, including days and times are being developed. We will be electing WSF officers – president, vice president, secretary, treasurer, district vice presidents. Please consider running for an office, and remember to vote in this election, too. Continue to watch for updates in this newsletter, on the WSF website and electronic updates from me.
- ◆ On a sad note, NW Cascade Chapter 196 and East Lake Washington Chapter 1404 recently closed. About half the members transferred to other chapters, with the other half becoming national-only members. So, I appreciate even more all that Chapter 1192 members are doing to keep their chapter open and viable.

## Legislative – Mary Binder

If you haven't read Marsha Padilla-Goad's article, page 10, May *NARFE Magazine*, I recommend it. While reading it, I thought about a children's book, *The Little Engine that Could* and the little engine saying, "I think I can, I think I can ..." when facing almost insurmountable odds. Marsha, NARFE's director, grassroots, wrote, "NARFE's success with postal reform legislation is one example of triumph through collaboration and persistence. After years of tireless lobbying and member grassroots activities, Congress passed an amended version of H.R. 3076, the Postal Service Reform Act of 2022 ..." which President Biden has signed into law. Per Marsha, "this bill provides financial relief to the agency and preservation of the mail service we all rely on. It also addresses the key NARFE concerns advocates have been fighting for ..."

Marsha's article highlights some of the challenges in the legislative process. She then wrote, "While the path is difficult, it's not impossible. It just takes numbers, collaboration and persistence. That's why member engagement in grassroots activities is an essential component of NARFE's long-term advocacy strategy to influence Congress' decision-making. When NARFE members communicate with their lawmakers – through meetings, letters and phone calls – about an issue relating to federal and postal employees' and retirees'
