

**NARFE Chapter 1192**  
**April 6, 2010 Chapter Meeting Minutes**

**CALL TO ORDER** President Nancy Crosby called the Chapter's regular monthly meeting to order at 12:04 p.m. Red Lion Hotel, Kennewick, Wash.. She called for a moment of silence for reflection on what has been going on in the world and to honor our service men and women, and introduced the head table, including the meeting's featured presenters – antique appraisers, Terry and Kathy Maurer. Nancy led the Pledge of Allegiance and recognized Nancy Carr, a friend of Carl Gallion's, Kay Mills-Poplin, a long-standing member who has not been able to attend a meeting for awhile, and two of the Chapter's distinguished members, Evie Norman and Lyell Bingham.

**MEETING MINUTES** Secretary Mary Binder highlighted the March Chapter meeting minutes. There were no comments or corrections. The minutes were approved. (Note: Minutes are posted on the Chapter's website, and copies are available at Chapter meetings.)

**TREASURER'S REPORT** Treasurer Bob Stewart highlighted the monthly treasurer's report. Balance on hand as of March, \$7,969.36. March receipts were \$599.30 and disbursements, \$744.10, leaving a balance of \$7,824.56. Projected dedicated funds are \$3,906.00, leaving an undedicated funds balance of \$3928.56. Bob thanked President Nancy for her assistance in preparing the report.

**Monies collected at the April meeting** Luncheon, 28 members and guests, \$299 collected; Alzheimer's Research Fund, \$53; NARFE-PAC, \$20; Newsletter Fund, \$15; and 50/50 Raffle, \$34 collected/\$17 awarded.

**DISTRICT/OFFICER/COMMITTEE REPORTS**

**President** No report.

**District VP** For VP Carl Gallion, President Nancy reported that Carl sends gratitude and thanks for the prayers, understanding and love. He loves all the cards, calls and visits. His hip is scheduled to be aspirated at the end of April. If there is no infection, then he will have hip surgery in May and begin rehab. Still projecting he will be out of the net until around June or July.

**1<sup>st</sup> Vice President** Gary Hagedorn provided an update on the upcoming District Spring Workshop, April 23, Red Lion Hotel, Yakima. He needs names by today for any Chapter members wanting to attend. (Projected to attend are: Johanna Caylor; Nancy Crosby; Mary Goldie; Sig Preston; Al and Dolores Rizzo; Nancy Schreckhise; and, Larry Williams. Part of the Chapter's "dedicated funds" cover members' registration.) Vic Rohret from the Yakima chapter is hosting the event in Carl's absence. Topics for discussion include: NARFE legislative issues; dues structure; and, membership recruitment and retention. Also, as Carl has submitted his resignation as District VP, a new VP will be elected at the workshop.

**2<sup>nd</sup> Vice President** No report.

**Alzheimer's** Chairman Bill Darke reported:

- There was \$288.94 in the Chapter's Alzheimer's account. He has lapel pins for contributions of \$20 and more, and will accept contributions after the meeting.
- He passed out copies of *NARFE's Participation in the National Alzheimer's Research Program* pamphlet. To date, NARFE members have contributed more than \$8M toward Alzheimer's Research.
- With the number of people affected by this disease, there is an ongoing need for research money.

**Hospitality** No report.

**Legislative** Co-chair Don Binder:

- Reminded members not drawing Social Security about the ir \$250 refund for tax year 2009.
- Provided a brief update on the recent health care bill, including that by 2014 members of Congress and their staffs will have to enroll in a health care plan and that for members under Medicare, a projected \$5B will be taken away from Medicare to help defray costs. Don encouraged Chapter members concerned about the new health care legislation to voice their concerns to our Congressional representatives.

**Membership** Chairman Johanna Caylor reported the Chapter had 15 "distinguished members" – those at least 85 years of age and who have been NARFE members for at least 20 years. They were recognized at today's meeting. **NARFE-PAC** Chairman Don Binder reminded members of the need for PAC contributions. Money goes to fund NARFE's legislative office and to candidates who are "4-square behind NARFE's issues."

**Newsletter** President Nancy reminded those who intend to submit information for the May/June newsletter that the deadline for submission to Mary Binder is Friday, April 9.

**Public Relations** Chairman Gary Hagedorn reported that he sent the Chapter's monthly meeting announcement to the *Tri-City Herald*, but it was not published.
