

**NARFE Chapter 1192**  
**February 1, 2017 Chapter Meeting Minutes**

**CALL TO ORDER** President Lorie Bennett called the meeting to order shortly before noon, Red Lion Hotel, Kennewick, Wash. Lorie asked members to silence all electronic devices, led the Pledge of Allegiance and called for a moment of silence for reflection to remember our military and those who have passed. She welcomed 22 members and 3 guests: Kristin Walls, today's program speaker; Margaret Walker (with Bill Hoyt); Wallapa Hendrickson, wife of Wally Hendrickson.

**Program** Kristin Walls, chief meteorologist, KVEW TV, provided a presentation on forecasting weather, including training required for a meteorologist, computer programs used, etc. An Ohio native, and Kent State (undergraduate) and Ohio State (graduate) alumni, Kristin said she has "always been fascinated by weather," everything from how weather happens to how storms develop. While working on her undergraduate degree in geography and climatology, she dabbled some in TV work. After receiving her graduate degree in atmospheric science, Kristin spent several years with a TV station in Steubenville, Ohio, before moving to Louisville, Kentucky. She moved to the Tri-Cities in June. Kristin said she "has a passion" for explaining the weather, how it works and for providing information to "keep people safe." She had a "behind-the-scenes" video shot at the studio the day before that showed the computer monitoring systems she uses and "the green screen" background used when broadcasting. Besides the weather, Kristin does a weekly wine segment that airs Wednesday mornings and evenings. A Q/A session followed the presentation. (**POC: Mary Binder**)

**President/Service Officer/Special Programs** President Lorie Bennett.

- Lorie welcomed Bob Stewart as a new director at large and the chapter's NARFE-PAC chairman and thanked him for volunteering. He is replacing Steve Howes who resigned effective January 1.
- Lorie thanked Steve for his service and presented him a letter of appreciation and certificate for distinguished service. Several members asked him questions about the new administration and current scenario. Steve said we are living in interesting times. He recommended members keep their "eyes and ears open to changes" and to "let our legislators know" of their concerns.
- Besides the food donations, members donated \$325 at the chapter's January food drive for the Tri-Cities Food Bank. Member Yvonne Sherman delivered the food and monetary donations; Lorie said she received a thank you letter from the food bank.
- Hospitality – Lorie reported that she has signed the 2017 chapter meeting contract with the Red Lion hotel. There is no increase in luncheon costs. - Balance on hand as of December 31, \$10,614.94. January receipts were \$850.55 and disbursements, \$408.85, leaving a balance of \$11,056.64. Projected obligations are \$2,640.00, leaving an unobligated balance of \$8,416.64.
- Nancy said Liz Bowers and Faye Vlieger are scheduled to conduct the audit of the chapter's 2016 financial records in February.

- With the new administration in office for just a few days, concerns being expressed by many individual across the country from all walks of life, and lot of media reporting – both accurate and inaccurate – Mary spent time sharing with and reinforcing with members the importance of remaining calm and informed; not believing everything heard and/or written; and,

continuing to use NARFE's information resources, e.g., the monthly *narfe* magazine; its website; the electronic *News Watch*; the *Daily News Clips*.

- Much is also happening at the state level with the legislature in session. Mary reminded members that Jason Mercier, director, Center for Government Reform, Washington Policy Center, is scheduled to be the guest speaker at the chapter March meeting.
- March 12-15 – Legislative Training Conference, Alexandria, Va. Registration ends February 10. Mary again encouraged members to consider attending this conference. **[Reminder from previous minutes:** It is a great opportunity to learn more about NARFE's legislative process and PAC. Speakers are excellent, and typically include nationally known individuals. The conference culminates in a trip to Capitol Hill to meet with the state's elected officials. The WSFC is offering a \$250 scholarship to each federation chapter member who attends the conference. The chapter will also be providing scholarships. As of now, Nancy, Pat and Mary are planning to attend.]

**Alzheimer's Chairman Bill Darke.**

- January chapter meeting contributions, \$45.50, bringing the chapter's Alzheimer's account balance to \$181.50. **[Note: A balance is kept in the account to keep it open.]**
