- AWSF Advisory Committee meeting was held on January 23 via ZOOM. Highlights:
 - Membership renewal and recruitment are the Federation's top priority.
 - The Federation now has just two districts Western and Eastern, down from the original five. Mary is the Eastern Washington District VP (three chapters) and Bea Bull holds the position for Western Washington (eight chapters).
 - Elections for WSF president, vice president, secretary, treasurer, and district vice presidents will be held in early fall. Only the two district vice presidents have indicated they are willing to continue in their positions. Candidates are needed for the other four elected positions.

"Sound bites" from ACTF's Amber Maiden (Operations Director), Riley Osborn (Development & Outreach Coordinator), and Blake Smith's (Executive Officer) presentation:

Primary speaker, Amber Maiden, talked on the "Progress in Building the Mid-Columbia Performing Arts Center" (Arts Center Task Force).

- Progress over the last year included appointments of Steven Wiley and Ted Miller to the Richland Public Facilities District (RPFC)
- Finalized building site (near the Reach Museum)
 - City of Richland and the FPFD working with the Project
- Information about the proposed building and the building site was presented.
 - 800 seats auditorium
 - \$40.8M total cost
 - Estimated revenue is \$1.40M
 - Completion of the build is anticipated to be 2028.
- First gala fund raiser, "Under the Lights" will be held on May 4 at the Reach Museum
- \$40.8M total build cost
- Projected attendance live music, musical theater, non-music theater, ballet, and other events is expected to be 59,700
