**Legislative** *Mary Binder.*

- Mary reported that Chris Eyler, executive director, Northwest Region Congressional and Public Affairs, Chamber of Commerce was the featured speaker at the February monthly Tri-City Regional Chamber of Commerce luncheon. He said that the Chamber’s top 3 priorities for 2015 are tax reform, regulatory reform and infrastructure. The Chamber is continuing to monitor what is happening with the Affordable Care Act and carryovers from the Obama Administration – the “overtime rule” and the expansion of the EPA’s water rules. Other areas being monitored include international trade, Medicare and Medicaid, and mid-term elections.
- March 12-15, Legislative Training Conference, Alexandria, Va. – Mary, Nancy and Pat are scheduled to attend. The agenda is out, including guest speakers. Mary noted that Congressman Derek Kilmer (WA-6) is scheduled as a speaker. He is known for being “a friend of NARFE.”
- April 1 – Veterans Service Fair, sponsored by Congressman Dan Newhouse (WA-4). Our NARFE chapter has been invited to be represented. Mary said this will be an opportunity to provide visibility for NARFE besides continuing to build relationships with the Congressman and his staff.

**Meeting Program** Jason Mercier, director, Center for Government Reform, Washington Policy Center, provided an update on the state legislative session, the state budget, other issues, and a look ahead. He started by thanking members for their service. Next, he shared that the policy center is a nonprofit, nonpartisan organization. His focus is on government reform; his counterparts focus on everything from budget to taxes to open government. Also to note, the political balance of the legislature resulting from the November elections “did not change much.”

The governor’s proposed budget reflects “the largest tax increases in state history.” Jason said he does not see that budget passing as “it is not sustainable.” The Washington State Supreme Court’s “McCleary” decision regarding the state’s underfunding of education remains the legislature’s top priority. Although the court is “fining” the state, it cannot legislate appropriations. Per Jason, “all of us are being sued [by the court], not just the legislature.” Currently, there were competing house and senate plans on how to fund education – one focused on funding based on staffing ratios; the other focused on funding through property taxes.

Jason spent time discussing the state income tax issue. This issue was first addressed in a state supreme court ruling 1933. The court ruled that “imposing a graduated income tax in Washington would require a constitutional amendment.” Since then there have been case law decisions defending this decision. However, to date, there have been 5 proposed constitutional amendments and 4 ballot measures proposing a state income tax – “linguistic gymnastics.” The voters have rejected these. Now, the latest attempt is a proposed test case involving only the City of Seattle.

This year’s legislative session is scheduled to end April 23. Jason said he believes it will be extended. **(POC: Mary Binder)**
