

**NARFE Chapter 1192**  
**May 3, 2017 Chapter Meeting Minutes**

**CALL TO ORDER** President Lorie Bennett called the meeting to order at noon, Red Lion Hotel, Kennewick, Wash. Lorie asked members to silence all electronic devices, called for a moment of silence to remember our military and those members who have passed, and led the Pledge of Allegiance. - Lorie reported that NARFE President Dick Thissen is encouraging members to contact their elected officials. This is a time when members need to be engaged.

**Treasurer's Report** *Nancy Crosby.*

- Balance on hand as of March 31, \$11,337.50. April receipts were \$606.25 and disbursements, \$1,634.95, leaving a balance of \$10,308.80. Projected obligations are \$1,374.00, leaving an unobligated balance of \$8,934.80.
- In April members Liz Bowers and Faye Vlieger conducted the annual audit of the chapter's 2016 financial records. Nancy reported they gave her "an A-minus" because she lost a check register. However, everything was accounted for.
- **Monies collected at the May Meeting** Luncheon, \$315; Alzheimer's Research Fund, \$36; NARFE-PAC, \$21; Newsletter, \$11; 50/50 Drawing, \$38/\$19 awarded (donated to Alzheimer's).

**WSFC President** *Nancy Crosby.*

- June 9-10 – Region IX Training Conference, Three Rivers Convention Center, Kennewick.  
**[To note: The training is especially targeted for newer NARFE members, but all members are welcome and encouraged to attend.]** The federation is paying the \$65

registration fee for all federation members who attend. The fee includes the dinner on June 9. The training starts at noon on the 9<sup>th</sup> and ends at noon on the 10<sup>th</sup>. As local chapter members do not have to travel and/or stay in a hotel, this means the conference is free to those chapter members. Guests are welcome to attend the training and/or dinner. To attend both the training and dinner, guests pay \$65; for just the dinner, it is \$30. There is a separate registration form for guests. Nancy had registration forms at the meeting and really encouraged members to sign up. Registration deadline is May 19. The agenda is still a work in progress.

- NARFE Strategic Planning Team/Committee – NARFE is continuing with strategic planning for the association's future. NARFE Region IX VP Rich Wilson serves on the team; Linda Silverio, Oregon federation president, serves on the committee. Meeting minutes and additional information are on the NARFE website.
- The federation directory of officers and chairmen, including chapter leaders, has been updated for the quarter. Nancy said leaders have received it electronically; it will not be posted on the federation website for security reasons.
- May 2018 – the next WSFC convention/conference. It will be in Spokane. Dates and location still to be determined.

**WSFC Alzheimer's** *Lorie Bennett.* Lorie reported that the federation is doing very well in donations. The federation's Alzheimer's year is May 1 through April 30. Lorie will have summary information for the year ending April 30 for the next chapter meeting.

**Secretary/Sunshine/Newsletter/PR** *Mary Binder.*

- May/June newsletter:
  - Finalized and distributed. Members at the meeting indicated they had received their copy, either mailed or electronic.
  - Mary reminded members about the "hidden numbers" in each issue. No one came forward and claimed theirs in the March/April newsletter. Mary said 2 members at the May meeting had their numbers in the May/June newsletter!
- May 7-13 – Public Service Recognition Week. There will be activities all across the country.
- June 8 – the annual Senior Life Show, Three Rivers Convention Center, 10 a.m. to 4 p.m. Admission is free. The chapter will again have a table with NARFE and chapter information. Liz Bowers and Pat Turner have volunteered to help Mary staff the table.
- Sunshine report:
  - Tom Brown, Walla Walla chapter president, had a stroke recently and is recovering.
  - **Continue to let Mary know of those members needing "a little sunshine."**

**Legislative** *Mary Binder.*

- Mary again provided handouts from the March NARFE Legislative Conference for those who did not get them at the April meeting.
- Mary asked members what their primary concerns were regarding legislation and the potential effects on both current and retired federal employees. Responses ranged from postal reform to healthcare.
- At the state level – the legislature is in its first special session as of April 24. While the legislature has accomplished much, there is still a lot to do, especially regarding school funding and a state budget.

**Alzheimer's** *Chairman Bill Darke.*

- The federation's fiscal year ended April 30. For the year, the chapter donated \$2,468.38. President Lorie said "let's give ourselves a hand."
- Bill reported there was currently \$22.50 in the chapter's Alzheimer's account. **[Note: a small amount is kept in the account to keep it open.]**
- NARFE reached its \$12 million goal before the end of 2016; its new goal is \$13 million by the end of 2018.

**NARFE-PAC Chairman** *Bob Stewart.*

- Bob provided members some results from 1<sup>st</sup> quarter contributions, January thru March:
  - Total chapter contributions were \$368, with \$83 collected at chapter meetings.
  - The chapter was 10<sup>th</sup> in the state of 21 chapters for contributions but first in the number of sustainers.
  - In Washington State, there were 189 contributors with 34 being sustainers.
  - Total contributions from the state for 1<sup>st</sup> quarter – \$8,681. Average contribution was \$45.93.
  - Total NARFE-PAC contributions for the quarters – \$226,828 with an average contribution of \$48.74. There were 4,654 contributors with 753 being sustainers.

**Meeting Program** Stephanie Button, administrative director, provided an overview and update on the East Benton County Historical Society Museum (EBCHSCM). Stephanie was raised in the Tri-Cities, went to CBC and then Western Washington University. She has a degree in anthropology. Before coming to the museum about a year ago, Stephanie spent 6 years at the REACH – working there “from the ground up.” She is the granddaughter of chapter member Ruby Ulseth.

Stephanie said that while the museum “is a history museum it is but not stuck in history.” Rather, the focus is to try “to be forward thinking.” Built in 1982, the museum has about 6,000 sq. ft. of gallery space, a basement for storage, and rooms that can be rented for everything from class reunions to meetings. The museum “easily has over 10,000 items, not counting arrowheads and the thousands of photos.” It is open noon to 4 p.m., Tuesdays thru Saturdays.

The museum was recently closed for a month so a complete inventory of “what we have” could be completed, Stephanie shared. A goal is to rotate some exhibits while others are more permanent, e.g., a timeline; Kennewick man; area railroads and bridges; area agriculture; WWI and WWII; a printing press; KONA LP albums; history of telephones and a switchboard; nostalgia (an old parlour and kitchen). Upcoming special programs: May – Hats in Fashion; August – Early Canals and Irrigation; October – a 35-year celebration of the museum’s opening; and, November – WWI and Benton County and the home front.

The museum does apply for state grants but currently receives no federal funding. It is a non-profit, 501(c)(3), organization. Stephanie had handout information about the museum, upcoming activities, making donations and being a volunteer.

In conclusion, Stephanie said, “A collection is an iceberg – you only get to see the top third.”
