- Tri-City Regional Chamber of Commerce monthly lunch/program, August 27. Chapter members Nancy Crosby, Al Farabee, Dot Stewart, Mary Binder attended. Congressman Dan Newhouse, (R-04) was the program/guest speaker; briefly talked with chapter members before the meeting. Presentation provided an overview/summary of key legislative initiatives, including through the end of the fiscal year, September 30. He stated he expects a continuing resolution to keep the government open. Demonstrators outside the hotel; increased law enforcement presence.
- Busy fall "outreach season" beginning. Activities listed in monthly handout NARFE/Tri-Cities Chapter 1192, 2025 Upcoming Events/Activities/Programs. Copies on each table. Dates, website references, and other important information. [Note: Copy attached to these minutes.]

Legislative/NARFE-PAC Coordinator Mary Binder.

- Federal:
 - Congress back in session; much to accomplish by September 30/fiscal year end.
 - o Continuing resolution likely to keep government open vs. a shutdown.
 - Use the NARFE Legislative Action Center to send letters to elected officials, especially for legislation NARFE advocacy staff is focused on.

State:

- Washington State Senior Citizens' Lobby NARFE Washington State Federation is a member; monthly (virtual) meetings on a variety of topics. Meetings are free; open to the public. Key presentations on the Lobby's website. (See events handout.)
- July 27 333 new laws took effect on a wide variety of topics, including: hiring more police officers; increasing the number of diaper changing stations; designating "EID," a holiday celebrated by Muslims, as a state-recognized (unpaid) holiday – the first state to recognize this holiday.
- Matt Murphy, Tri-City Regional Chamber of Commerce government affairs director, scheduled to provide a state legislative update at the March 2026 chapter meeting.

NARFE-PAC:

- Third quarter PAC reports results NARFE Region IX (Alaska, Idaho, Montana, Oregon, Washington) continues to be a strong PAC supporter, e.g., again had the highest "mean average" of NARFE's 10 regions despite being the smallest region.
