#### **Chapter President – Lorie Bennett**

Fall is definitely here and winter no longer a distant mark on the calendar. Each season brings changes, year in and year out – some easy, some maybe not so easy, but we deal with them. That is,



we enjoy the "ups" and work through the "downs."

Sound familiar? Maybe the roller coaster of the stock

market recently? Or, the who's in/ who's out coverage of the midterm elections? Regardless, there will be changes. Then, what about the good news – a 2.8-percent COLA but then,



an announcement about a potential postal rate increase? More ups and downs, and changes.

On the NARFE front, changes, too. The recently elected new president, Ken Thomas, begins his 2-year term November 1. Even this year's election process was yet another change for NARFE with the new "one member, one



vote." While it may sound simple, the implementation and low percentage of NARFE members actually voting proved otherwise. An example – only 7.22% of NARFE members voted in the runoff election for president. In our state, the percentage was even lower, 7.15%; but, for Chapter 1192, the percentage was better at 11.44%.

As if all this were not enough, OPM is also working through changes. Director Jeff Pon, who spoke at the NARFE's **FEDcon18** conference, resigned recently after only 6 months as director. Then, in a recent announcement, "just days before the Civil Service Reform Act" turned 40, OPM's acting director, Margaret Weichert, announced several hiring and compensation changes that are "a host and a portfolio" of other changes to come.

Yes, a sample of changes, but we will "weather" them. So, as we move forward, watch for slippery sidewalks and roads! And, a very Happy Holiday Season to you.

#### WSF President – Nancy Crosby

Our Washington State Federation (WSF) board had a meeting at the Tacoma La Quinta Hotel, September 10. Minutes are posted on the federation website: <u>www.narfewa.net</u>. Highlights included the resignation of the vice president, Karol Kusunose, and the selection and installation of Mary Binder to complete the term. Also, District IV's vice president, Al Costa, had to resign due to moving to Oregon. Bea Bull from Bremerton Chapter 181, agreed to fill the position and was unanimously approved by the board via email subsequent to the board meeting.

The board's next meeting is scheduled for December 6, again in Tacoma. A primary focus will be finalizing the federation's 2019 budget. Earlier in the year,

the board voted to suspend each chapter's "per capita tax" for 2019, which is \$1.20 per member. The board is encouraging chapters to use the funds for recruiting and



retaining members, and/or assisting members who attend NARFE conferences or training with expenses. The 2019 federation budget will also identify funds for "scholarships" to help offset members' expenses for NARFE Legislative Training Conference, **LEGcon19**, March 10-13, Washington, D.C., and the Region IX Training Conference, May 17-18. District VPs and chapters will be provided a copy of the finalized budget.

Recruiting and retaining NARFE members continues to be challenging. For example, NARFE gained 13,792 new members and/or reinstatements through August but also lost 19,818 due to non-renewals and deaths for a negative loss of 6,026. So, a reminder that NARFE's fall membership drive runs through December 31. See below!



Finally, our Emerald Chapter 1701 is officially closed and we are awaiting word from NARFE on the official closure of our Walla Walla Chapter 237. Nationally, NARFE has closed 201 chapters since 2016, including more than 65 thus far in 2018. So, thank you to all who are working to keep our Tri-Cities Chapter 1192 open and viable! <u>5538</u>

#### Legislative – Mary Binder

As this newsletter "goes to press," the midterm elections are looming. With much at stake for

many, it will be interesting to see if the voter turnout exceeds the average for midterm elections. Have you voted?



A reminder – the October narfe magazine, pages 29-40, has a "special pullout section," that NARFE provides so "members may be as informed as possible about the representatives and senators seeking re-election to Congress, and how these legislators have represented the concerns of active and retired federal employees."

Recently, Congressman Dan Newhouse (R-04) and Derek Kilmer (D-06) visited each other's districts as part of a

"civility and respect" tour, as their graphic, right, depicts. Both are members of the Congressional Civility and Respect Caucus. Representative Kilmer wrote in his recent newsletter, "The group formed



as a response to some of the incivility our country has experienced in recent years." Further, he wrote, that he joined the group "because, despite what's on cable news every night, I believe it is possible to disagree without being disagreeable."

After the tour, Congressman Newhouse wrote in his newsletter that while he and Congressman Kilmer "disagree on many policy issues, we have fostered and maintained a friendship and positive working relationship. We are both members of the House Appropriations Committee and participate in a monthly meeting of a Bipartisan Working Group. We have introduced legislation together, such as the VA Management Alignment Act, and we have worked together on several important issues, such as combating the opioid crises and putting an end to school violence. 2061

#### NARFE-PAC – Bob Stewart

The 2017-2018 congressional cycle is coming to an end, December 31. The 8th and final quarter started October I. Per Ross Apter, NARFE political associate, the 7th quarter ending September 30 "was a busy one," which was expected considering the midterm elections.

At the end of the 7th quarter, NARFE members had contributed \$1,825.831.51 to NARFE-PAC since lanuary 1, 2017. This exceeds NARFE's goal of \$1,500,000 for this cycle! Of that, \$52,325.70 came from our Washington federation members, including \$3,767 from Tri-Cities chapter members. This placed the chapter 7th in the state. However, with 8

Total disbursements for Washington, \$32,500.
