## Vice President – Nancy Crosby

**Apathy!** If you look up the meaning, it reflects indifference, boredom, lack of concern, lack of interest. Recently, the NARFE Washington State Federation (WSF) conducted a **3-day, free, virtual,** annual meeting and biennial conference. I understand virtual does not replace in-person, but the WSF board did a lot of planning to bring speakers and presentations of interest for all members. I was amazed, and disheartened, at the lack of interest WSF members demonstrated. In our Tri-Cities chapter alone, we have 218 members; yet, only 2 or 3 of us “attended” the sessions, even though members could select what they could/wanted to attend, that is, log in and out of the conference based on their interests and schedules. Each day’s attendance averaged about 18 members, of which 4 were WSF officers, out of 4,200 WSF members!



This number is in line with the recent WSF officer elections. Only 101 members voted! Granted, there was only one person running for each office; but, the new WSF president, Cray Henry, is a national-only member who heeded the call for nominees when he understood no one was running for federation president.



This same **apathy** was also demonstrated in the recent NARFE national officer elections. In 2022, out of all ballots distributed, only 6.67% were returned. In the 2020 election, only 7.4% were returned. Ballots were in the *NARFE Magazine* and available online.

These results make me wonder – what are we, your chapter officers, doing wrong? For example, are we not publicizing events and elections in a way to ensure every chapter member gets the information in a timely manner? We no longer can blame COVID on the apathy. What can we do to improve, to encourage more participation?

Please! Take the time to let us – your chapter officers and committee coordinators – know what we can do to change this apathy and improve! We want to keep our federation and NARFE viable. Please let us know how we can better serve you!

“Busy” describes our Washington State Federation (WSF) this fall! Chapter VP Nancy referenced the 3-day October virtual WSF conference in her article, this page. The agenda included NARFE national, regional and state updates. Washington State Lieutenant Governor Denny Heck talked with attendees and Washington Secretary of State Steve Hobbs discussed election security. There was a very informative presentation on scams from 2 AARP instructors, and a thought-provoking memorial reflection from Sister Pat Millen from Spokane.

WSF election results were announced at the conference. Cray Henry is the new WSF president and Mary Traxler, the new VP. Both Secretary Linda Wallers and Treasurer Arlene Patton were re-elected, as were Bea Bull, District III VP and me for District I. Verna Wright was elected to the vacant District II VP position.

As for the 6 Eastern Washington District I chapters: Spokane Chapter 32, Tri-Cities Chapter I 192 and Colville Valley Chapter 1247 are meeting; Columbia Basin Chapter 856 is now officially closed; Wenatchee Chapter 239 is in the process of closing; and Yakima Chapter 238 is planning a special member meeting to discuss that chapter’s future. - ◆ Repealing GPO/WEP – NARFE “continues to advocate for passage of the Social Security Fairness Act, H.R. 82.” NARFE continues to “push to ensure House leadership brings the bill to the floor for a vote.”
- ◆ Regardless of the November 8 election results, it will remain important to stay engaged with our elected officials. Note! Pages 47-58, October *NARFE Magazine*, have summary information regarding how our elected officials voted in the 117th Congress.
- ◆ NARFE’s 2023-2024 advocacy positions document is now on the NARFE website. According to the site, “These positions provide an extensive and specific enumeration of NARFE’s member-endorsed positions on legislative and administrative policies and will serve as a guide for NARFE’s advocacy endeavors in 2023 and 2024.” For the document and more information, after logging into the NARFE website, [www.narfe.org](http://www.narfe.org), click on the Advocacy tab, then Advocacy Update on the dropdown tab.
