

The 2026 premiums "rate charts" are now available. As expected, premiums are increasing - on average, 12.3%. Our NARFE Washington State Federation website. www.narfe.org/wa/ has a link to the charts; or, another option, go to https://www.opm.gov/healthcare-insurance/ healthcare/plan-information/premiums/. Changes can be made for 2026 even during the government shutdown. Suggestion: Take a few minutes to review your plan, the costs, etc., even if you are satisfied with your plan. Most plans have at least some changes.

Periodically check your personal information on the NARFE website. Is it up to date? After logging in, go to the "For Members" tab, then the "Log in to the Member Portal" tab. Scroll down to the "Profile" tab.

- Then, too, is all your "designated beneficiaries" information up to date for things like life insurance, Roth accounts, the Thrift Savings Plan?
- NARFE's F-100 booklet, Be Prepared for Life's Events, is a great tool. It is available on the NARFE website and at chapter meetings.



A government "shutdown" was still a reality as this newsletter was finalized. NARFE's advocacy staff has compiled much helpful information, including answers to frequently asked questions and links to other pertinent sites. It is posted on the NARFE website, www.narfe.org, updated as information changes, and is available to NARFE members and nonmembers. During these times, NARFE is seen as a "trusted source" for government shutdown-related information, so check the website and recommend it to others who may need or want shutdown information.

Staying connected with our elected officials remains as important as ever during these challenging times. Whether in person or in writing, letting them hear from their constituents is critical.

On October 2, I had an opportunity to talk with both Congressman Dan Newhouse (R-04) and his wife, Joan, at the annual "elected leaders reception" hosted by the Tri-City Regional Chamber of Commerce at The Reach Museum. (photo, right) These "meet and greet" events are important in

developing and maintaining relationships with elected leaders and their staffs.


