The name change will be phased in by 2006.

**NARFE-PAC** (William Darke):

"Politicians do not have an easy life. Somebody is always interrupting it with an election." --*Will Rogers*

Today we have a sound retirement system and a model group health insurance plan. We worked and paid for these benefits during our careers so we could depend on them in our retirement. In order to maintain our benefits, we must remain watchful to ensure that Congress doesn't take actions that would reduce them.

This year is an election year. If you've been watching, you are probably aware that the Bush administration is proposing medical savings accounts for our health insurance program. This would allow the young and healthy members to opt out of the regular risk pool and pay lower rates for reduced coverage. This would have the effect of dividing the risk pool, leaving the older and less healthy retirees to pay higher premiums for their existing coverage. The Kerry camp, on the other hand, wants to open the FEHBP to the uninsured, which would five four three four probably not be to our benefit either.

One way we can try to stem the onslaught on our benefits is by contributing to NARFE-PAC. For a donation of \$15 you can help preserve our benefits and receive a lapel pin in recognition of your contribution. For the 15 month period ending March 31, 2004, only 12 of our more than 300 members have made contributions and the contributions totaled \$305. I would like to thank those who have contributed, and would like to see more of you join the fight to preserve our benefits. Please use the forms in your NARFE magazine or see me at one of the chapter meetings and I will send it in for you.

**Legislative Report** (Pierre Saget) :

Of potential interest to those who have or will have Social Security (SS) income in addition to CSRS income is a new Windfall Elimination Provision (WEP) bill HR 4391 introduced by Rep. Kevin Brady (R-TX). This new bill would provide increased benefits for low and medium-wage earners but a decreased benefit for high-wage earners and would essentially amount to another method of "means testing" for SS benefits. NARFE President Fallis voiced concerns: ie; doesn't repeal or reform GPO, that federal retirees who have 30 years or more of SS earnings would no longer be exempt from WEP, and finally he urged full repeal of the WEP & GPO and was supported in this by several state teacher's associations.

A second issue of much more importance requires support from each of our members. On July 8, 2003, the House responded to NARFE's concerns when it passed HR 2631, a bill introduced by Rep. Tom Davis (R-VA) that would require FEHBP to provide a prescription drug benefit for federal annuitants age 65 & older that would be at least as generous as the drug coverage available to other FEHBP enrollees, namely annuitants age 64 and younger and active federal workers. Approval by the Senate Committee on Governmental Affairs chaired by Sen. Susan Collins (R-ME), a federal-friendly lawmaker, would clear the measure for action by the full Senate.

But time is running out in the current congressional session. The committee and Senate must act between Sept. 7<sup>th</sup>, when Congress reconvenes and as early as October 1<sup>st</sup>, when it will probably adjourn. *That is why now it the time for all NARFE members to deliver the following message to both of their Senators by phone, fax or e-mail:*

"I urge you to protect my earned FEHBP drug benefits by asking Chairwoman Susan Collins and the Senate Governmental Affairs Committee members to Approve S.1369 and H.R. 2631 at their earliest opportunity. I would appreciate a response from the senator to my mailing address at: \_\_\_\_\_" All NARFE members can use the toll-free number, 1-866-220-0044 to reach the Capital switchboard and ask for the Senator by name.

The **2005 Legislative Conference** dates are set: Saturday, February 26 through Tuesday, March 1, 2005. Typically, Sat. is registration and an evening reception and/or dinner. Sun & Mon are the break-out sessions and speakers (lunches and dinners), and Tuesday is the visit to Capitol Hill. ). **Our chapter should strive to have an attendee for this upcoming conference in 2005.**

**Service Officer News** (Estelle Bellefeuille):

**“PROTECT YOUR PENSION”** (excerpted from Anna May Hanson, Service Officer, Chapter 1701 Renton). Good advice from the National Center for Retirement Benefits tells us to.

#1. When STARTING WORK, create a “pension File.” Keep all documents from your employer or pension plan, copies of letters and memos about the plan, and compensation records, including W-2’s and Social Security Forms.

#2. Educate yourself about how your plan works.

#3. If you think your pension is incorrect, hire a professional to check the numbers. Most errors involve wrong years of credited service, failure to calculate benefits for those who worked past 65, and mistakes with average earnings and interest rates. **Living Benefits Claim Form (FE-8)**

Use: Enrollees who are terminally ill with a life expectancy of 9 months or less use this form to claim living benefits under the FEGLI program.

Electronic Copies: There are no electronic copies of this form.

**Employees** who wish to apply for a Living Benefit must contact OFEGLI by calling 1-800-633-4542. OFEGLI will send you an application form.

**Annuitants** who wish to apply for a Living Benefit must contact OFEGLI by calling 1-800-633-4542. OFEGLI will send you an application form.

Agencies **cannot order** the FE-8.

**FEHB Open Season dates for 2004 are November 8 – December 13, 2004. Changes in enrollment are effective January 1, 2005. Local FEHBP Fairs will be held in Tri-Cities on October 21<sup>st</sup>. SSA-Kennewick: 9:00 – 10:00 a.m., Richland Fed. Bldg: 11 am – 1:00 pm; and Stevens Center 2:00-4:00 pm. **Tricare for Life** may be advantageous to many Medicare-eligible military system beneficiaries who are now covered under the FEHB Program as Federal civilian retirees, family members, or former spouses. Any federal employees, retirees and survivors who are eligible for Tricare for Life and want to **suspend** their FEHBP enrollments should contact the Office of Personnel Management at **1-888-767-6738** to obtain the necessary forms.
