## WSF President – Nancy Crosby

For the first time, ALL NARFE members had the opportunity to vote for NARFE officers, either online or with paper ballots issued in the *narfe* magazine; however, only 6.77% of NARFE members voted. In our Washington federation, the percentage was 6.32%. Of the state’s 5,820 members, only 368 voted. For the Tri-Cities chapter, 22 of 239 members voted or 9.21%, better than the average.

While a new NARFE secretary/treasurer, Kathryn Hensley, was elected, none of the 4 candidates running for NARFE president received the majority needed. Therefore, a runoff election is now being held for 3 of the 4 candidates (one has dropped out of the race). As NARFE members approved using “preferential voting” during the recent election, this ranking system will be used for the runoff. (See page 46, May *narfe*, for details

on preferential voting.) Members will again be able to vote electronically or by using the paper ballot inserted in the September *narfe* magazine. I encourage all members to vote. Note! All votes must be received by 11:59 p.m., September 30. So, if you are using a paper ballot, recommend allowing a week for delivery. Either way, please vote!



As President Lorie wrote in her article, several board members are scheduled to attend **FEDcon18**. Besides the conference, I am scheduled to attend the joint NARFE Executive Board and Federation Presidents’ Meeting prior to the conference. I’ll be providing highlights at the chapter’s September meeting. **4157**

With the closing of the Walla Walla chapter, 3 federation chapters have closed over the past year. Also closed are Tacoma Chapter 163 and Emerald Chapter 1701, and there may be more making the same decision.



While this is a trend throughout NARFE, experiencing it in our own federation definitely brings it closer to home. So, a thank you to all chapter members who are working to keep the Tri-Cities chapter open and viable.

The next federation board meeting will be Monday, September 10, at the La Quinta Inn & Suites, Tacoma. All members are welcome to attend. Since the last Chapter 1192 newsletter, we did appoint Steve Roy from Everett Chapter 193 as the new federation national legislative chairman. We are looking forward to his guidance. Also, the membership chairman position remains vacant, and is one that could be co-chaired; and, our vice president, Karol Kusunose, had to resign so we are looking for a replacement. ## Legislative – Mary Binder

August is NARFE Grassroots Advocacy month; but, that certainly doesn't mean advocacy stops August 31! For NARFE and all of us, it is ongoing and year round. As President Lorie wrote in her article, it is important to stay engaged; and, from NARFE in a recent *Advocacy Alert*, "To be successful in our efforts, you must stand united with fellow NARFE members."

Further, "Spreading the NARFE message in unison across the nation is crucial to the success of our efforts, and will set the scene for how legislators perceive the issues when they return to Washington in September. Legislators are more likely to weigh in on legislation when they hear from multiple constituents about that issue. So make your voice heard in the way you feel most comfortable ..."



With SO much proposed legislation, it is sometimes hard to know where to focus. NARFE's Advocacy Department recommends focusing on the following "Big 3" talking points:

- ◆ Support a Modest Pay Increase for Federal Employees in 2019;
- ◆ Prevent Federal Benefits Cuts; and,
- ◆ Modify Postal Reform Legislation

Switching from the national level to a local focus, consider RiverFest 2018, Saturday, September 8, Columbia Park, Lampson Pits, 11 a.m. to 3 p.m. This "fun and free" event "for the whole family"

## NARFE-PAC – Bob Stewart

The NARFE-PAC quarterly reports for the period March 1 through June 30 are on the NARFE website. These reports are for the 6th quarter and have summary information for 2017/2018, congressional cycle.

A quick summary – as of June 30, chapter members had contributed \$2,620 to NARFE-PAC through money collected at meetings, sustainer contributions, one-time contributions, etc. This placed the chapter 6th in the state, up from 9th in the previous quarter. However, with 7 sustainers, the chapter ranked first; and, interestingly, the state ranks 5th in sustainers of all 50 states and national-only members!

So, looking ahead with fall elections looming closer and closer, contributions are needed more than ever as this is the time when more PAC distributions are typically made to candidates who have requested PAC support and who support NARFE's legislative agenda. To note, as of June 30, \$26,500 had been disbursed to state candidates during this 2-year cycle, ranking the state 5th of the 50 states in the amount of NARFE-PAC dollars disbursed. This is noteworthy!
