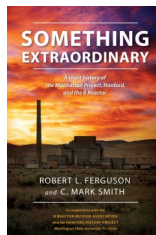

September brings an end to NARFE's annual August Grassroots Advocacy Month; however, that does not mean an end to advocacy! With the November elections "heating up," several things come to mind:

- ◆ First, a reminder that NARFE is NONPARTISAN. Political, yes, but NONPARTISAN. NARFE focuses on protecting our earned pay and benefits, NOT on a political party. It is sometimes difficult for members to separate personal politics from the NARFE agenda, but when representing NARFE, we MUST remain NONPARTISAN.
- ◆ From the August *narfe* magazine, "NARFE encourages its members, employees, families and communities to participate in the political process." NARFE has state-specific and other election information at: [www.narfe.org/GOTV2020](http://www.narfe.org/GOTV2020).
- ◆ Also from the August *narfe* magazine, "Addressing WEP and COLAS 'have long been at the top of NARFE's legislative agenda, and now is the time for us to push congressional action.'"

## NARFE-PAC – John Wetterling

NARFE-PAC has been affected by COVID-19, BUT the good news, per Ross Apter, NARFE political associate, in the August *narfe* magazine, "... the PAC quickly adapted to ensure that NARFE's issues remained at the forefront. As campaigns began to better understand operations during the coronavirus outbreak, so did NARFE-PAC ... The PAC embraced the new era of Zoom calls and joined candidates in virtual fundraisers to make sure our strongest supporters had the funds necessary to continue successful campaigns ..."



The 6th Quarter PAC reports for the 2-year, 2019 to 2020, congressional cycle ending June 30 are on the NARFE website. Good news is contributions have continued! Here are some 2-year highlights:

- ◆ NARFE goal: \$1,750,000; raised, \$1,730,928.39.
- ◆ Disburse: \$1,250,000; disbursed, \$1,074,000.
- ◆ Grow sustainer program 20%; grown 11%.

Regarding the sustainer program, our Tri-Cities chapter remained 2nd in the number of sustainers of the state's 16 NARFE chapters. With even just a couple more sustainers, we could be in first place!

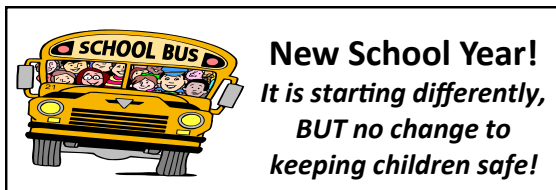
