

Service Officer (Acting) - Nancy Crosby November 11 to December 9 will be open season for 2025 health benefits changes for both the FEHB and new PSHB programs. We are planning to host another evening health fair as we did in 2023. Date, time and location will be announced once we know when the providers will be in our area.

For Postal employees and retirees, the USPS has prepared a guide to the new Postal Service Health Benefits Program. Also, we just learned of a "catch" in OPM's proposed regulations for the USPS program involving Medicare-eligible retirees and Medicare Part D prescription drug coverage. This is a complex issue! "In its proposed regulations for the new PSHB program, OPM asked for feedback on how best to mitigate the risk of 'inadvertent disenrollment,' as well as how to educate Part D-eligible individuals on details of the new program." (Federal News Network, July 24, 2024, Drew Friedman article.)

At the September chapter meeting, we will have copies of the guide and Part D article; or, contact me for a copy if you cannot make the meeting.

Legislative/NARFE-PAC - Mary Binder

Urgent Action Alert! NARFE has learned that a "discharge petition" is expected to be filed September 10 in the House of Representatives in an attempt to move H.R. 82, The Social Security Fairness Act, to the House floor for a vote. Despite

having 325 co-sponsors, enough to bring the bill to repeal GPO/WEP to the floor, it has been stalled in committee. An attempt around this is a discharge petition, which "in U.S. parliamentary procedure ... is a means of bringing a bill out of committee and to the floor for consideration without a report from the committee by 'discharging' the committee from further consideration of a bill or resolution." (Source: Wikipedia) BUT, 218 member signatures are needed! Even if a legislator is a co-sponsor, they MUST come to the House floor to sign the discharge petition. At FEDcon24, attendees were asked to contact their legislators asking for their support, and to encourage their

At **FEDcon24**, attendees were asked to contact their legislators asking for their support, and to encourage their chapter members, other NARFE members, to also do so! The time frame is VERY SHORT as the House will only be in session for a brief time in September before legislators depart for their home districts until after the November 6 election. At the NARFE website, after logging in, go to the Advocacy tab, then Take Action. Scroll down to "Support Bringing the Social Security Fairness Act, H.R. 82, to a Floor Vote through a Discharge Petition" for more details and to contact our legislators.

Good NARFE-PAC news! Again,

our Region IX was first in "mean" (average) contribution out of the 10 NARFE regions. At \$111.21, this far exceeded the \$66.39 mean. Thank you to all who are supporting PAC!
